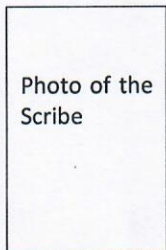
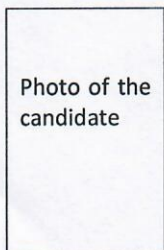

SELF DECLARATION BY CANDIDATE AND SCRIBE

We, the undersigned, Mr./Ms./Mx. _____ eligible candidate for the National Institute of Fashion Technology (NIFT), application no. _____ Name of the program to be held on 06th February, 2022 and Mr./Ms./Mx. _____ eligible writer (scribe) for the eligible candidate, do hereby declare that:

1. The scribe is identified by the candidate at his/her own cost and as per own choice.
2. The candidate is blind/low vision or affected by cerebral palsy with locomotor impairment and his/her writing speed is affected and s/he needs a writer (scribe) as permissible under the Government of India rules governing the written examination for Persons with Disability.
3. As per the rules, the candidate availing services of a scribe is eligible for compensatory time of 20 minutes or part thereof for every hour of the examination for General Ability Test (GAT), which is a MCQ paper.
4. Creative Ability Test (CAT) and Situation Test are specialized test to judge the creativity and cant not be taken with the help of scribe. However candidate may avail 30 minutes extra time. Spelling and sentence formation of the candidate will be ignored.
5. In view of the importance of the time element, the examination being of a competitive nature, the candidate undertakes to fully satisfy the Medical Officer of the Institute or their representative, that there was necessity for use of a scribe as his/her writing speed is affected by the disabilities mentioned in Point 2 above.
6. We hereby declare that all the above statements made by us are true and correct to the best of our knowledge and belief. We also understand that in case it is detected at any stage of admission process that we do not fulfill the eligibility norms and/or that the information furnished by us is incorrect/false or that we have suppressed any material fact(s), the candidature of the applicant will stand cancelled, irrespective of the result of the test(s). If any of these shortcomings is/are detected even after the candidate's selection, his/her candidature is liable to be cancelled. In such circumstances, both signatories will be liable to criminal prosecution.
