The cost of the visiting the campus shall be borne by the bidder.
- 3. Bids received shall be evaluated as per the criteria prescribed in the tender document. NIFT will not entertain any modifications subsequent to opening of bids and bids not conforming to tender conditions shall be liable to be rejected. Therefore, bidders are advised to submit their bids complete in all respects as per requirement of tender document specifying their acceptance to all the clauses of Bid Evaluation Criteria, GeM terms and condition, Additional terms and Condition, Special terms and condition, General terms and conditions and compliance to the Scope of Work requirement etc.

B. TENDER TERMS & CONDITIONS:

- 5. All the firefighting equipment should be checked, serviced and tested thoroughly once in a month without fail.

- 7. Cleaning and lubrication including polishing of all brass parts should be done once in a month with necessary lubricants.
- 8. NIFT Bengaluru reserves the right to drop or add any part of the work/ item and AMC contractor should carry out the work as per the quoted rate per item/ work.
- 9. All the components should be checked thoroughly to work in perfect conditions and it should be ensured that all the safety devices work perfectly. Checking vibration, polishing should be carried out once in a month along with service.
