NIFT shall provide separate Counselling room with basic facility to Visiting Doctor.

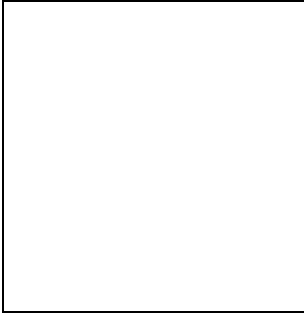
A. Evaluation of EOI proposal:

If required, eligible professional may be called for a discussion with the committee or institute authority in order to assess the suitability of the person.
