<u>Clarifications on Instructions for post of Scanner Operation</u> Executive under INDIAsize Project

- It is compulsory to carry a photo ID such as Aadhar Card, Voters Card, Driving License, ID issued by Government or other offices where candidate is working. Candidates without ID cards will not be allowed entry in examination hall/ skill test and interview venues.
- 2. The candidates are required to report for examination at 09:30 am at G-1, Ground Floor, New Building NIFT Delhi Campus on 11th January 2019.
- 3. The Structure of examination is as follows:
 - Written test -50 marks. Written test will have following components
 - o English language and Comprehension,
 - General Awareness
 - Quantitative Aptitude & reasoning Assessment
 - Domain Knowledge of Computer application
- 4. Candidates must write the exam/ indicate the answer in their own handwriting.
- 5. Use of mobile phone, calculator and other electronic gadgets and their accessories in not permitted. Therefore, these should not, be brought inside the examination premises/ venue.
- 6. Candidature of any candidate found to posses mobile phone or any other means of the wireless communication or related accessories either in the working or switched off mode shall be cancelled.
- 7. The candidates are advised to desist from use of any influence/ unfair method in the examination hall, which will render them ineligible for further consideration for the examination and also lead to their debarment from NIFT's examinations on future besides inviting criminal prosecution.
- 8. The list of qualified/ Shortlisted candidates on the basis of their performance in the written Examination will be uploaded on NIFT 's website<u>www.nift.ac.in</u> and will be called for Skill test and interview
 - Skill test for testing computer skill 20 marks
 - Interview -30 marks

Those who are not short listed on the basis of written Examination will not be considered further for recruitment process.

- 9. The short listed candidates are required to report for interview at 09:30 am at G-1, Ground Floor, New Building NIFT Delhi Campus on 12th January 2019.
- 10. Final result of the candidates will be declared on basis of combined marks obtained in skill and interview in order of merit.
- 11. The candidate will also be required to bring original documents and one self attested copy of the educational and experience Certificate for verification during the interview.
- 12. Wrong declarations/ submission of false information/ documents or any other action contrary to law shall lead to cancellation of the candidature at any stage.
- 13. The mere possession and fulfilling the essential qualification and appearing for the test and interview doesn't entitle the applicants to be selected.
- 14. Candidates are advised to make their own arrangement for transportation and stay in Delhi. No TA /DA shall be paid.
