SUBJECT: DECLARATION OF RESULT FOR SELECTION TO THE POST OF COMPUTER ENGINEER IN NIFT

In accordance with the advertisement no. 10/Direct Rectt-Contract-Group-A&B Posts/2019 dated 1st October, 2019 uploaded on the NIFT website, the Written Examination for the post of Computer Engineer was held on 4th April, 2021 and 137 candidates appeared for this Examination.

2- The process of selection comprises of Written Test (Paper-I) and Written Test(Paper-II). The declared pattern of examination and weight-age of marks are as under:

- Marks obtained in Paper-I shall be considered only as a qualifying benchmark for evaluation of Paper-II. Paper-II shall be evaluated only in respect of those candidates who have secured minimum cut off marks in Paper-I as decided by the Competent Authority based on the number of candidates and posts
- Selection shall be made in the order of merit on the basis of marks obtained in Paper-II (Skill/Technical Test)

3- The Competent Authority has approved following criteria for the written test scores. The Marks for **Paper-I & Paper-II** were 60 in each paper and the cut %age/marks decided by the Competent Authority for Paper-I & Paper-II is as under :-
