
Subject: Submission of Immovable Property Returns (IPRs) by officers of Group A Central Services for each year and placing the same in public domain-reg.

Please find attached herewith an O.M no. 11013/3/2011-Estt.(A) dated 11th April, 2011 and subsequent clarification dated 23rd September, 2013 issued by Department of Personal & Training, Ministry of Personal, P.G & Training on the subject cited above.

2. DoPT vide its O.M dated 11th April, 2011 and subsequent clarification dated 23rd September, 2013 has clarified that IPRs of all the Group A officers may be placed in public domain by 31st March of that year. Further, a report in respect of Group 'A' Services controlled by the Ministry/Department and offices belonging to General Central Services Group 'A' under the Ministry /Department may be sent to DoPT by 30th April, every year.

3. You are therefore requested to follow the instructions issued by DoPT and IPRs of all the Group A officers of NIFT may be placed in public domain by 31st March of that year and a report in respect of Group 'A' officers may be sent to DoPT by 30th April, every year. Further, it is also advised that the report in respect of year 2015 may be placed in public domain latest by 20th August, 2016.


Subject : Submission of Immovable Property Returns by officers of Group A Central Services for the year 2010 (as on 01.01.2011) – Placing of the public domain regarding.

Rule 18 (1) (ii) of the CCS (Conduct) Rules have provision for submission of annual property returns in respect of immovable property by all Group 'A' and 'B' officers by 31st January of each year. Conduct Rules for Railways and other Rules in respect of Central Government servants contain similar provisions.

2. It has been decided that the immovable property returns submitted by members of all Group 'A' Services of the Central Government for the year 2010 i.e. as on-01.01.2011 will be placed in public domain by the respective cadre controlling authorities by 31.05.2011. A copy of the circular in this connection issued by Establishment Officer to all Ministries/Departments is also enclosed herewith.

3. All the Cadre Controlling authorities in respect of Group 'A' Central Services are requested to ensure compliance. They are also requested to report status on 31.05.2011.



The undersigned is directed to refer to this Department's O.M of even no. dated 11/04/2011 requesting all Cadre Controlling authorities to place in public domain the IPRs of Group 'A' Officer for the year 2010 by 31.05.2011.

CIRCULAR

Subject:- Submission of Immovable Property Returns by IAS officers for the year 2010 (as on 1.1.2011) – Placing on the public domain regarding.

Sir,

As per Rule 16(2) of AIS (Conduct) Rules, 1968, all the members of the Service are required to submit their Immovable Property Returns (IPRs) latest by 31st January every year. Vide this Department's circular of even number, dated 22nd December, 2010, all State Governments and Central Ministries/Department were requested to forward Immovable Property Returns of all IAS officers for the year 2010, to the Department of Personnel and Training (DOPT) latest by 15th February, 2011. Subsequently D.O. letter were issued to all Chief Secretaries by Secretary, DOPT to forward the IPRs of all IAS officers borne on their cadre latest by 26th March, 2011.

2. It has been decided that officers who do not submit the property return in time would be denied Vigilance Clearance and will not be considered for promotion and empanelment for senior level posts in Government of India. Government of India have also decided that the annual property return as on January 1, 2011 of members of All India Service and other Group 'A' Central Service Officers will be placed in the public domain.

3. Against this backdrop, it is once again requested that IPRs all IAS officers working in the State Governments and Central Ministries/Dept. be forwarded to reach us positively by 5 P.M. on 20.4.2011.
