A) Fee for non-NRI students Academic year 2015-16.



1. Student repeating this semester will be required to pay the re-registration fee of Rs. 5000/- per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim fee besides the above mentioned amount.
2. Last date of depositing the fee for July-December, 2015 UG-III, V, VII and PG –III (except B.F.Tech-VII & M.F. Tech. III) is **10.08.2015**. Fee with a late fine of Rs. 100/- per day can be deposited till **24.8.2015**.
3. Last date of depositing the fee for B.F. Tech. VII is **08.09.2015** and M.F. Tech. III is **02.09.2015**. Fee with a late fine of Rs. 100/- per day can be deposited till **14.09.2015** (B.F.Tech VII and M.F.Tech III).
4. Last date of depositing the fees for the session January to June, 2016 is **19th January, 2016**.
5. Fee with a late fine of Rs. 100/- per day can be deposited till **2nd February, 2016**.
6. The name of the student will be struck from the institute rolls without any further notice due to non-payment of fee after the specified date.
