

1. Last date of depositing the fee for July-December, 2016 is **9th September, 2016**. Fee with a late fine of Rs. 100/- per day can be deposited till **19th September, 2016**.
2. Last date of depositing the fees for the session January to June, 2017 is **24th January, 2017**. Fee with a late fine of Rs. 100/- per day can be deposited till **7th February, 2017**.
3. The name of the student will be struck from the institute rolls without any further notice due to non-payment of fee after the specified date.

Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are requested to contact their concerned campus before the commencement of the session and to complete the formalities. Such students will be required to pay the re-registration fee of Rs. 5000/- per absencing semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim fee besides the above mentioned amount.
