1. At given point of time there will be four stalls in CCIC New Delhi showroom.
2. An area of 40 Sq. Ft. shall be made available to each designer. Vacant space shall be provided by CCIC. Display, interior and other infrastructure shall be set up by Designer.
3. Qualification: Degree from a recognized University / Deemed University, an institution approved by AICTE, an institution set up by an Act of Parliament / State Legislature or an institution substantially funded by Govt. of India or State Government.
4. Experience : 3 years retail experience in his / her own label / supply to a reputed store.
5. Revenue sharing in respect of sales proceeds (net of discount / taxes) will be in the ratio of 65 (Designer) : 35 (CCIC)
6. Label - "xyz for cottage"
7. Handloom items / dresses shall be permitted to be marketed.
8. The following slots are available:
 - a). 01 DEC 2016 to 31 MAY 2017
 - b). 01 JUN 2017 to 30 NOV 2017

9. A Designer can apply for more than one time slot. The EOIs received will be evaluated by a committee nominated by CCIC. If there are more than four eligible shortlisted applications for a time slot and shortlisted for a showroom, then the successful applicants shall be selected through a process of draw of lots in the presence of the shortlisted applicants.
