National Institute of Fashion Technology [NIFT was set up by the Ministry of Textiles Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006)] for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 17 centers. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program to address the specialized needs of professional and students in the field on fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhi Nagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Panchkula, Raebareli, Shillong and Srinagar.

Department/PSUs/MNCs Reputed Academic Institutes/Organizations.

Terms & Conditions:

- 1) Please read the terms & conditions carefully before filling up the document. Incomplete tender documents will be rejected.
- 2) Conditional or offline tender will not be accepted or the condition(s) may not be considered.
- 3) The Financial Bids of technically qualified bidder only will be opened.
- 4) Even after qualifying in technical bid, the financial bid may not be accepted if found not in order.
- 5) The tenderer must have at least 3 years of experience in the relevant field and execution of similar kind of works in the Govt., PSU, reputed MNCs/ organisations.
- 6) 'Credential' issued by the officer not below the rank of Exe. Engineer of the deptt./ sector will be accepted.
- 7) In case of L-1 is more than one, the selection criteria [viz. the past performance, experience, turnover, etc.] would be at the discretion of NIFT. The decision of NIFT, in this regard and for selection of successful bidder in such situation, will be final in all respect and will be binding on all the tenderers.
- 8) Lowest bid may not be the only criteria for selection and NIFT is not bound to issue work order to the agency being the 'L-1' bidder; weightage/ preference will also be given to the other factors, viz. previous experience, quality of service, number of client, yearly turnover, etc. to select the agency to award the work and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the tenderers.
- 9) All Taxes & other charges, if any, should be mentioned clearly; otherwise, the rates will be treated as all inclusive. Statutory rates are subject to change and will be considered as may fixed by the Govt.
- 10) Annual financial turnover/profit loss account during the last 3 years, ending 31st March of the previous financial year, should be at least **Rs.75 lakh**.
- 11) Experience criteria: Experience of having successfully completed similar works during last 3 years ending last day of month previous to the one in which applications are invited should be either of the following:
 - a. Three similar completed works costing not less than the amount equal to **Rs.15.00 lakh**.

- c. One similar completed work costing not less than the amount equal to **Rs.5.00 lakh**.
- 12) Definition of "similar work" should be clearly defined.
- 13) The successful bidder needs to deposit Security Money of 10% of the Work Order value through Demand Draft favoring NIFT Bhubaneswar which will be refunded/ returned, without any interest, after one year from the date of completion of the work with deduction, if any and as applicable.
- 14) The works should be completed within **04 weeks** from the date of receiving of Work Order failing which a penalty @0.5% of the order value per week will be imposed subject to a maximum of 10% of the Order Value. However, delay due to any applicable/ unforeseen reason, viz. natural calamity, non-availability of site etc., may/ may not be considered as may be decided by NIFT Authority.
- 15) All statutory obligations under various laws, imposed from time to time will have to be met by the contractor for which no extra payment shall be made to him. NIFT will no way be responsible for any default with regard to statutory obligation, if any.
- 16) The quotes should be valid for at least 6 months from the date of opening of the tender however, for the successful bidder the rates will be valid till completion of the job.
- 17) No payment shall be made in advance. The payment shall be made after commissioning of works and on the basis of certification by the concerned NIFT Official(s). TDS etc., if any and as applicable, will be deducted during payment.
- 18) The quantity of items of work may vary and payment will be made based on actual.
- 19) NIFT shall not provide any mode of transport in respect of men or material required by the contractor for execution of the work.
- 20) Any query/ clarification with respect to the tender (T&Cs, specification(s), etc.) may be cleared prior to submission of bid; concerned NIFT official(s) may be contacted in this regard in between 10 am to 5 pm on any working day (**0674-2305700**). NIFT will not entertain or clarify any such query during post bid.
