- Preference will be given to those who are enrolled in other PSU's for similar assignment and holding doctoral degree.
- At least Ten years' experience in the field is mandatory.

#### 3. Other terms and Conditions:

The empanelled counselor shall be required to visit NIFT, Delhi Campus on three days in a week for two hours each and as and when required for specific assignments. Counselor is expected to counsel students having problem ranging from anxiety and depression arising from study issues / results / home sickness / life issued to more serious mental health problems. Life issues could include bereavement, relationship difficulties or any such issued of adolescence, while mental health problems could including eating disorders, post traumatic stress disorder or psychosis.

- **Appointment & Tenure: -** The engagement shall be purely on temporary basis for a period of one year which will be extendable upto three years. Further extension yearly basis shall be reviewed at the end of the year on satisfactory performance only.
- **Emoluments**: Counsellor has to visit three days in a week for three hours each and will be paid consolidated amount of Rs.45000/- per month.
