MNC's reputed agencies, and who have carried out similar / civil works on item rate basis as per the requirements and details as given below. The Quotations shall be super scribed with AMC of Aquaguards at NIFT Campus, Hauz Khas, New Delhi. to be submitted in the tender box at 1st Floor, H-Block, Delhi Centre by 3.00 P.M. on 28-05-2018 to be opened on the same day at 3.30 P.M.

The site can be inspected 10:00 A.M. to 5:00 P.M. during working hours on any working days. No extra shall be payable for non awareness of the site conditions and constraints.

NIFT reserves the right to accept or reject any quotation in part or whole without assigning any reason thereof.

CONDITIONS

- 1. The rates shall include cost of labors & material for the works complete in all respects.
- 2. The quoted rates shall include GST/ALL TAXES etc. as applicable and no extra shall be payable on this account.
- 3. Rates shall be valid for one year from the date of work award.
- 4. Water and Electricity will provide free of cost at one point for bonafide use.
- 5. The agency must enclose copy of the GST Registration certificate & PAN Card or PAN No. of the company/Proprietor and work experience certificate / work order for having executed the similar/ civil works. Quotation of any agency without above shall be rejected outrightly.
- 6. Work shall be completed within one year issue the work order.
- 7. The experience certificate / work order of reputed agency for similar work / AMC of aqua guards with the details of total work amount (Total work amount/ work order not less than 80% of total estimated cost of work) should be submitted with NIO.
- 8. The payment shall be made on half yearly basis in advance after submitted bill by Aquaguards.
- 9. Agency is advised to see the site before quoting the rates, in working days. (Monday to Friday 10:00AM to 5:00PM)
- 10. Service covered by the contract are as follow:
- a. Two periodical service visits per year during the period of contract, when the purifier attachment will be thoroughly checked, cleaned, serviced and adjusted.
- b. Any additional visits during the contract period, as and when required, in the event of breakdown, malfunctioning of the equipment, on intimation in this regard by the NIFT within maximum 48 hour.
- c. Replacement of per-filter candle will be made twice (minimum) in every year depending on the condition of the existing pre filter candle during the service contract period. Two candles per year will be replaced maximum as per site requirement.
- d. Replacement of activated carbon granules will be made twice/activated carbon block one minimum twice in a year during the service contract period.
- e. Replacement if worn-out exhausted parts, including ultra violet lamp with new/rectified spares during the periodical servicing of breakdown visits during the service contract period.

g. All faulty parts/PVC pipe/electronic circuit/ card of aqua guard machines affected by electricity, damaged due to any reason may be replace by the contractor. These all parts/shall be the part of AMC No extra payment shall be made to the AMC vender on this account during AMC period.

h. The AMC shall includes repair of existing faulty aquaguards, if any. No extra shall be paid on this account.

- i. During AMC if PVC connection pipe will required to change, that shall be replaced with same length of the existing pipe.
- j. The AMC of aquaguards can be extended further 02 years on the basis of satisfactory performance of work on same rates, terms & conditions.

11. Risks:

Contractor shall be solely responsible for safety of his workers, working at site by following all safety norms in the trade.

All risks of loss or damage to physical property and of personal injury and death which arise during and in consequence of the performance of the Contract other than the excepted risks are the responsibility of the Contractor. Excepted Risks are:

(i) war, hostilities (whether war be declared or not), invasion, act of foreign enemies.

(ii) rebellion, revolution, insurrection, or military or usurped power, or civil war,

(iii) ionizing radiations, or contamination by radio-activity from any nuclear fuel, or from any nuclear waste from the combustion of nuclear fuel, radio-active toxic explosive, or other hazardous properties of any explosive nuclear assembly or nuclear component therefore.

(iv) pressure waves caused by aircraft or other aerial devices traveling at sonic or supersonic speed.

- (v) Loss or damage due to the use or occupation by the Employer of any section or part of the Permanent Works, except as may be provided for in the Contract.
- (vi)loss or damage to the extent that it is due to the design of the Works, other than any part of the design provided by the Contractor or for which the Contractor is responsible.
