- **4.** Tuition fee for the **2**nd **semester January-June 2024** (Non-NRI students admitted in NIFT Delhi in 2023-24 Academic Year):
 - **a.** The Non NRI students admitted in 2023-24 Academic Year are required to pay the tuition fee for January-June, 2024 (2^{nd} semester) as published in the prospectus 2023 i.e. Rs. 1,43,000/- (One Lakh Forty Three Thousand Only).
 - **b.** Fee for NLEA Non NRI students admitted in 2023-24 Academic Year are required to pay the tuition fee for January-June, 2024 (4th semester) as published in the prospectus 2023 i.e. Rs. 1,43,000/- (One Lakh Forty Three Thousand Only).

The students are required to pay the applicable fee as per the schedule mentioned below and to note the NIFT rules on non-payment and re-registration:

- I. Last date of depositing the fee for the semester July-December, 2023 is 18^{th} September, 2023. Fee with a late fine of Rs.100/- per day can be deposited till 3rd October, 2023.
- II. Last date of depositing the fees for the semester January to June, 2024 is 15^{th} February, 2024. Fee with a late fine of Rs. 100/- per day can be deposited till 28^{th} February, 2024.
- **III.** The name of the student will be struck from the institute rolls without any further notice in case of non-payment of fee after the specified date.
- **IV.** PG students of 3rd Semester will be required to pay the Alumni Association Membership Fee (One time) (Non Refundable) of Rs. 5,600/-.
- V. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence (LOA) are required to contact their concerned CCs before the commencement of the session to complete the formalities. Repeat students will be required to pay the re-registration fee of Rs. 10,000/ + 18% GST = Rs. 1,800/ = Total Rs. 11,800/per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim and Exam Fee over and above mentioned amount.
