- 3) The work shall be executed with ISI Mark material and as approved by NIFT official.
- 4) The minor changes can be held during the execution of work.
- 5) The rate should be inclusive of transportation, labour and all taxes as applicable and nothing shall be paid extra.
- 6) **EMD is Rs. 3,000/- (Rupees Three thousand only) which is refundable.** It can be deposited by demand draft of National bank in favour of "National Institute of Fashion Technology" payable at Gandhinagar /Ahmedabad. No interest will be paid on Earnest Money Deposit.
