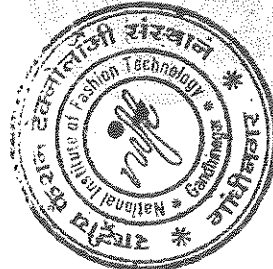

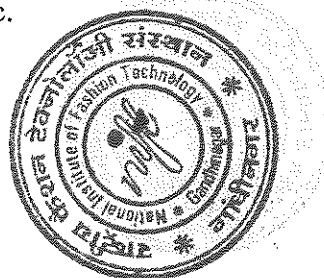
### **TERMS AND CONDITION:**

1. The sealed tenders super scribed with “Tender for sale of Used Maruti SX4 Car (Petrol & CNG)” and addressed to the **Officer on Special Duty** along with the earnest money of Rs. 4500/- (Rupees Four Thousand Five Hundred only) should be **submitted/dropped in tender box kept at Administration Department at GH-0, Extension Road, Nr. Infocity, Gandhinagar on or before 11.02.2019 up to 3.00 pm.**
2. **Tender must be submitted with duly attested photocopies of the following documents :-**
  - 2.1. **Individual Bidders:**
    - (a) Photocopy of residential Proof (Passport, Driving License, Voter Identity Card, Ration Card).
    - (b) Photocopy of PAN Card
  - 2.2. **Firm / Partnership Firm / Company etc.**
    - (a) Photocopy of registration certificate of Firm / company / Partnership deed.
    - (b) Photocopy of PAN Card
3. Offers should be submitted in **Price Bid Format** only
4. Any offer received without the EMD and/or without prescribed tender form along with terms and conditions of the tender duly signed by will not be considered.
5. The delivery / handing over of vehicle will be on proof of valid Identification Card the purchaser.
6. After the date of possession of vehicle by the successful bidder, NIFT will not be liable in any manner regarding its use & misuse.

7. The Highest offer of the vehicle will be treated as successful tender, provided the same is accepted by the Institute and have submitted valid requisite documents.
8. The highest bidder shall have to deposit the bid amount in the form of Demand Draft / Pay Order drawn in favour of NIFT, Gandhinagar within 3 days on receipt of confirmed sale order from NIFT.
9. Earnest Money will be forfeited in case the successful tenderer fails to make the balance payment of vehicle within the stipulated time.
10. The Earnest Money deposit will be returned to the unsuccessful tenderers after the acceptance of the offer to the successful tenderer. However, No interest shall be payable on EMD.
11. NIFT reserves the right to accept/reject any bidding, to postpone / suspend or to cancel the whole process of the sale at any time without assigning any reason.
12. GST & TCS at applicable rate and transfer charges and other RTO fees if any will have to be paid by the successful tenderer as per the Govt. Rules over and above his / offer.
13. If the highest quoting firm fails to honor the bid; the contract will be cancelled & its EMD will be forfeited. In such event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1 party.
14. Tendering form should be signed by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
15. The delivery of the vehicle shall be made after completing sale formalities as required by R.T.O., Gandhinagar.
16. The vehicle will be handed over on "As is where basis" and no claim for repair/maintenance etc. will be entertained by the NIFT.
17. The road tax / insurance / passing of vehicle/transfer charges/road fitness charges etc. shall be born by the purchaser and NIFT shall not be responsible for the same.
18. In case of backing out from the tender process/taking of delivery of the vehicle, the earnest money will be forfeited.
19. All Petrol/CNG/Diesel/tow away charges, if needed will be borne by the purchaser.
20. The purchaser shall be bound to remove the vehicle within 2 days after the settlement of payment/other formalities etc.
