Terms & Conditions:

1. Your tender must be sent to the Purchase department in closed sealed envelope marked with "Rate Inquiry for Garba Set up including stage setup, Musical Instruments and Orchestra" or else liable to be rejected.
2. Last date of receipt of sealed tender documents is 28th September, 2019 by 11:00 A.M. and will be opened on same day at 12:00 (Noon).
3. The rate offered must be filled in this rate inquiry letter only. Any correction should be initialled by the tenderer in the rate inquiry letter liable to be rejected.
4. Rates should be offered unconditionally and if rates are submitted with any condition the tender will be liable to be rejected.
5. The quoted rates should be inclusive of all taxes and other charges if any, nothing shall be paid extra.
6. L1 agency will be decided based on total amount quoted by bidders.
7. In case of operational exigencies, Institute may shorten the event for 2 days. In such case payment will be reduced on prorata basis.
8. Timings of Garba will be 8.00 pm to 12.00 (Mid-night).
9. The Firm should have attached necessary document like copy of PAN Number and copy of GST Registration certificate. GST Unregistered firm should submit undertaking clearly stating that "GST is not applicable looking to the turnover of agency".
10. Payment will be made in the name of bidder only and not to the proprietor/partners.
11. The successful bidder will have to organise Garba setup as per the above requirement within the define time frame of the issuance of the work order, failing which the firm will have to bear the entire cost of the alternate arrangement or the fine as decided by the NIFT.
12. Payment of the supply will be released after verification and satisfactorily completion of order.
13. NIFT reserves the right to reject any or all tender documents without assigning any reason thereof.
14. In case of any dispute raised by the supplier, a representation will be made only by the authorized representative of the supplier and the decision of the Director NIFT – Gandhinagar will be binding on the supplier.
15. In case of any dispute the Jurisdiction of Court will be Gandhinagar.
