1. Your limited quotation must be sent to the Building Department in sealed envelope marked with "Quotation for **Providing and fixing of Soft board at NIFT Centre, Gandhinagar** or else liable to be rejected.
2. **Last date of receipt of sealed tender is 22/10/2019 upto 3.00 pm and will be opened on same day at 4.00 pm.**
3. The quotation fee is **Rs. 125/- (non-refundable)** and **EMD is Rs.2300/- (refundable)**. Both will be deposited in form of demand draft of national bank in favour of "National Institute of Fashion Technology" payable at Gandhinagar /Ahmedabad. No interest will be paid on Earnest Money Deposit.
4. L1 agency will be decided based on the total amount quoted by bidders.
5. All the material should be as approved and work should be executed as directed by NIFT Official.
6. The above quoted amount will be inclusive of cost of all material, transportation, labour and taxes as applicable, nothing shall be paid extra.
7. The necessary civil work and cutting of old for fixing of cover shall be including in quoted rate.
8. **10% work order amount as Security Deposit/Performance** Guarantee shall be held with NIFT for six month and released after satisfactory performance with no defect condition without any interest.

9. EMD amount of successful bidder will be converted in performance gurranty and balance amount of SD will be adjusted from final bill amount.
10. EMD will be forfeited if the successful bidder back out after opening of tenders.
11. The Agency has to complete the work within 30 days after receipt of work order.
12. The Qty. of items may vary at the time of execution hence payment shall be made on actual basis on submission of final bill.
13. Payment will be made only the name of bidder firm (not in the name of proprietor/partner /Director).
14. In lieu of any defect the work shall be repaired by the agency if NIFT desires so.
15. In case of non-performance, in respect of stipulated time period for completion or defect liability of One Year after completion of work depending upon the case, the decision of Director, NIFT shall be final.
16. In case of any dispute the Jurisdiction of Court will be Gandhinagar.
17. Agency fails to complete work within 30 days from the receipt of work order, Rs: 1000 /- per week or part thereof up to Rs: 5000/- maximum will be deducted as Liquidity Damage.

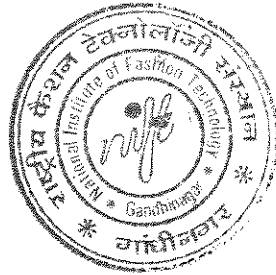
