The above Old UPS will be available for inspection from **05.12.2019 to 30.12.2019** between 10 am to 5.00 pm. at NIFT Gandhinagar Campus, GH – 0 Road, Near Infocity, Gandhinagar 382007 on all working days except Saturday, Sunday and Public Holidays.

TERMS AND CONDITION:

1. The sealed tenders super scribed with **"Tender for Sale of Used UPS "** and addressed to the **Officer on Special Duty** along with the earnest money of Rs. 4500/- (Rupees Four Thousand Five Hundred only) should be **submitted/dropped in tender box kept at Administration Department at GH-0, Extension Road, Nr. Infocity, Gandhinagar on or before 31.12.2019 up to 3.00 pm.**
2. **Tender must be submitted with duly attested photocopies of the following documents :-**
 - 2.1. **Individual Bidders:**
 - (a) Photocopy of residential Proof (Passport, Driving License, Voter Identity Card, Ration Card).
 - (b) Photocopy of PAN Card
 - 2.2. **Firm / Partnership Firm / Company etc.**
 - (a) Photocopy of registration certificate of Firm / company / Partnership deed.
 - (b) Photocopy of PAN Card
3. Offers should be submitted in **Price Bid Format** only
4. Bidder must be registered e-Waste management agency with appropriate government agencies (State pollution control Board / Central Pollution Control Board) to handle such material. Copy of registration certificate for the same must be provided by the bidding agency failing which bid will not be considered.
5. Tenderers are requested to submit this tender document duly signed each & every pages.
6. Any offer received without the EMD and/or without prescribed tender form along with terms and conditions of the tender duly signed by will not be considered.

7. The Highest offer will be treated as successful tender, provided the same is accepted by the Institute and have submitted valid requisite documents.
8. The highest bidder shall have to deposit the bid amount in the form of Demand Draft drawn in favour of NIFT, Gandhinagar within 3 days on receipt of confirmed sale order from NIFT.
9. Earnest Money will be forfeited in case the successful tenderer fails to make the payment against sale order within the stipulated time.
10. The Earnest Money deposit will be returned to the unsuccessful tenderers after the acceptance of the offer to the successful tenderer. However, No interest shall be payable on EMD.
11. NIFT reserves the right to accept/reject any bidding, to postpone / suspend or to cancel the whole process of the sale at any time without assigning any reason.
12. GST & TCS at applicable rate and other Govt. charges if any will have to be paid by the successful tenderer as per the Govt. Rules over and above his / offer.
13. If the highest quoting firm fails to honor the bid; the contract will be cancelled & its EMD will be forfeited. In such event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1 party.
14. Tendering form should be signed by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
15. Handing over of items shall be made after completing all official formalities.
16. The UPS will be handed over on "As is where basis" and no claim for repair/maintenance etc. will be entertained by the NIFT.
17. The purchaser shall be bound to remove the UPS within 2 days after the settlement of payment/other formalities etc.
18. Any dispute arising against this disposal, the decision of the competent authority of NIFT shall be final and binding.
19. Disputes, if any shall be subject to jurisdiction in the Court of Gandhinagar only.
