## **INSTRUCTIONS**

- 1. E-Bids are invited through the electronic tendering process of "Annual Rate Contract for Providing Carpentry Services at NIFT Gandhinagar campus" and document has been published on the Central Public Procurement **Portal** (URL:http://eprocure.gov.in/eprocure/app). A copy of the Tender Document is also https://www.nift.ac.in/gandhinagar/tenders). **NIFT** website (URL: available on The submission of e-Bids will be only through the Central Public Procurement Portal will (URL: <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>).Bids not be accepted in other form. The prospective bidders should adhere to deadlines specified in tender details on the portal.
- 2. The Tenderers are expected to accept all Technical/Commercial terms & Conditions mentioned in the Bid documents.

#### 3. PRICES, TAXES, DUTIES

The Agency should quote firm rates plus applicable taxes for such works/services, for the Time period as indicated in the bidding document and no variation on above account will be allowed during execution of the Contract.

- 4. Taxes will be applicable as per prevailing rates of Government from time to time.
- 5. It is the responsibility of tenderers to read all terms & conditions of this tender Carefully before filling the tender. Incomplete tender documents / or bids not Responsive enough to the tender terms shall be rejected. NIFT reserves the right to split or reject any or all the tenders without assigning any reason thereof.
- 6. Any vagueness/incomplete details in the offer shall make it liable to be rejected as such shortcomings in the offer shall be interpreted as incompetence and disinterest on the part of the Tenderer to meet tender requirements.

## 7. GUIDELINES FOR ONLINE BID SUBMISSION

As per the directives of SOI of Expenditure, this tender document has been published on the Central Public Procurement Portal (URL: <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal. ## 8. Registration

- a) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
- b) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.

- c) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- d) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / n-Code / e-Mudhra etc.), with their profile.
- e) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- f) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

## 9. Searching for Tender Documents

- a) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.
- b) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective "My Tenders" folder. This would enable the CPP Portal to intimate the bidders through SMS / email in case there is any corrigendum issued to the tender document.
- c) The bidder should make a note of the unique Tender ID assigned to each tender in case they want to obtain any clarification / help from the Helpdesk.

#### 10. Preparation of Bids

- a) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- b) Please go through the tender document carefully to understand the documents required to be submitted as part of the bid.
- c) Bidder should prepare in advance, the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.

#### 11. Submission of Bids

- a) Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- b) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- c) An indicative BOQ format has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided on CPP Portal and no other format is acceptable. Bidders are required to download the BOQ file, open it and complete the Blue/Aqua colour (unprotected) cells with their respective financial quotes and other details (such as name of

- the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.
- d) The server time (which is displayed on the bidders (dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- e) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128-bit encryption technology. ### **GENERAL CONDITIONS OF THE CONTRACT**

1. The Tender contains the Item rate for Repair & Maintenance of Furniture and Building Interior items.

## 2. Eligibility Criteria:

- a. Tenderer should have minimum 02 years' experience of carpentry work in Govt. / Semi Govt. / PSUs / Private Organizations. Copies of work completion certificate / Work order must be submitted in support of this. The requisite information should be furnished in Annexure-A of this tender document.
- b. Tenderer should have annual turnover of Rs. 3.00 Lakh per year in each last three financial years (i.e. 2019-20, 2020-21 & 2021-22). Copies of Audited report / CA Certificate must be provided in support of the same. The requisite information should be furnished in Annexure-A of this tender document.
- 3. The tender is liable to be ignored if complete information is not given there-in, or if the particulars and data (if any) asked for in the schedule to the tender are not filled in.
- 4. Quantities given are purely tentative and have been proposed for finalizing lowest tenderer on overall basis.
- 5. Tenders shall remain valid for acceptance by the NIFT for a period of three months from the date of opening of the price bid, which may be extended by mutual agreement.
- 6. National Institute of Fashion Technology does not bind itself to accept the lowest or any tender and reserves the right to accept or reject any or all the tenders either in whole or in part, without assigning any reasons thereof.
- 7. It is mandatory to quote the rates for all the items in price bid contrary to which the Price Bid shall not be considered for financial evaluation and the Agency's Bid thereof will be liable to get rejected.
- 8. The lowest (L1) tenderer shall be evaluated on the basis of lowest in <u>Grand Total amount (including GST) of Price Bid</u>. In case of L1 being more than one then deciding criteria for award of work will be tenderer having more no. of years of experience in the Government organizations.
- 9. Time shall be considered as the essence of the contract and Agency shall complete the work within the period mentioned in the indent or the instructions issued by the NIFT's Engineer. In case the Agency fails to complete the work within the time stipulated, liquidated damages at the rate of 0.25% per week or part of a week of the bill of indented work would be recovered from the agency. Decision of Director, NIFT, Gandhinagar campus shall be remained final in this regard.
- 10. The Agency shall provide, maintain and replenish necessary tools, tackles and accessories including equipment and their spares as required for the day-to-day working. In case of theft or any kind of loss, NIFT would not be held responsible for the same.

- 11. The tenderer must obtain for himself on his own responsibility and at his own expense all the information which may be necessary for the purpose of tendering and for entering into a contract and must inspect the site of the work and acquaint himself with all local conditions, means of access to the work, nature of work and the matters pertaining thereto.
- 12. The Agency is requested to understand the scope of work before quoting their rates. The quoted rates shall be remain same during the period of contract
- 13. The Agency's attention is drawn to the fact that the rate quoted for each and every item shall be self-supporting, workable and shall be quoted keeping in view the <u>facts as per point no. 8</u> of this part. While asking for execution of work during the period of ARC the Agency has to execute the work for indent issued which may be very small also. No claim or compensation shall be entertained in this regard.
- 14. The rates quoted for each item shall be for complete item at site category wise as per quotation format. The rate quoted by the tenderer shall be all-in-rate including Salestax. Excise Duty. Octroi and any other taxes and duties or other charges levied by Central Goyt, or any State Goyt, or Local Authority. The rates quoted shall be firm and shall not be subject to exchange variations, labour conditions, fluctuation in Railway/Road freights or any other conditions whatsoever. The rates shall also include transportation, loading, unloading, packing, forwarding, freight charges, transit insurance cover etc.; for keeping and arranging various items required for the work as directed by the NIFT. The rate shall also include breaking/dismantling the existing work wherever required/directed, roughening the surfaces to receive new work and removing the debris out of the Premises & disposing it at specified area as directed. The rate quoted shall include for all lift-lead and necessary scaffolding to enable the Agency's to work at any level (height) of the building. Rates will also include for all labour, parts, materials, tools, drilling, plant, equipment, transport, which may be required in preparation for, in the full and entire execution and completion of any new work or, reconstruction or repairs within the contract area, and making good all the damages caused during the execution of work at no extra cost. However, if there is unexpected rise in price of some material/labour it may be considered during renewal/extension subject to justification submitted by Agency & acceptance by NIFT's Authority.
- 15. The successful tenderer shall be required to implement the contract within the time specified in the work order. The Agency will commence the execution of works in consultation with occupant/user, caretaker and/or concerned engineer of NIFT. The Agency shall make all necessary arrangement for supervision/inspection of works being carried at NIFT and make available all tools/equipment for measurements/verification of NIFT's Engineer.
- 16. Selection of sample of materials/brand/manufacturer will be of best quality & as mentioned in quotation or as approved by NIFT's Engineer.
- 17. The Agency shall make his own arrangements for safety, security and protection of his manpower and materials and the completed work till the same is taken over by NIFT.
- 18. For repairing & maintenance works the quoted rates shall be inclusive of all materials, labourers, T&P, preparation of surfaces/area, scaffolding, Drilling if any for execution of works as per the specifications and directions of the NIFT's Engineer etc.

- 19. The Agency has to obtain prior permission or all its workers to be deployed at NIFT for carrying out the work and for the works which are to be carried out on Saturday / Sunday, Holidays and beyond working hours.
- 20. The work has to be carried out during/after office hours and with least inconvenience to the occupants/functioning of the office.
- 21. The Agency shall take all precautions and observe adequate safety measures during execution of Services, and shall not hamper movement of students / staff.

#### 22. **DEFECT LIABILITY PERIOD**

Any defect or fault which may appear during <u>3 months</u> from the date of virtual completion of work/or supply and installation in full as specified under the contract, arising in the opinion of the NIFT's Engineer regarding materials or workmanship which shall not in accordance with the contract, shall be intimated in writing and the same shall be rectified and make it good by the Agency at his own cost within reasonable time as specified therein. In case, still there is a fault, NIFT may engage and pay other person/s to rectify and to make good the such defects/faults/damages, and expenses consequent there upon or incidental thereto shall be borne by the Agency and/or such damages, loss and expenses shall be recovered from the Agency, or may be deducted from any payment/deposit due or that may become due to the Agency.

23. The Agency will take full responsibility for using the materials specified in the schedule. If at any stage it is found that the specified materials are not used, penalty at the rate of 0.25% of the bill of indented work would be recovered from the agency from its bills/security deposit.

#### 24. **Security Deposit:**

The Contractor whose tender is accepted, will be required to furnish by way of Security Deposit, an amount equal to 3% of the tendered value of the work in the form of Demand Draft payable to NIFT, Gandhinagaror by transferring Security Deposit amount in NIFT Gandhinagar General Account no: 359302050000198 (IFSC Code: UBIN0535931) (Fifth Character in IFSC code is "Zero").

- 1) No interest shall accrue on this deposit, which will be returned after the successful completion of contract and after adjusting dues if any of the agency to NIFT.
- 2) The security deposit shall be released to the Agency on virtual completion of the Annual Rate Contract period. But in case of extension, the deposit shall be released after completion of extension period.
- 25. All the damages to the furniture, walls, floors, false ceilings, ducting, fixtures and fittings belonging to the NIFT or of the residents/quarters, etc. or the work of any other agency

- during the execution of work shall require to be repaired/replaced by the Agency at his cost or else the same shall be adjusted/recovered from the Security Deposit amount.
- 26. In all matters of dispute arising on the work, the NIFT's decision will be taken as final and will be binding on the Agency.
- 27. The agency will send the carpenter along with the required material as and when required by the Institute.

#### 28. Insurance clause:

- a. It will be the responsibility and liability of the Contractor to have Accident Insurance Policy of its staff to cover accidental risk as per Workmen's Compensation Act, during repair and maintenance work. NIFT will not be liable/ responsible in this regard in any manner.
- b. The Agency shall be responsible for anything which may be excluded from the insurance policies above referred to and also for all other damages to any property arising of and incidental due to negligence or defective execution of this contract. He shall also indemnify the Employer in respect of any costs, charges or expenses arising out of claim or proceedings of damage arising there-from.
- c. The Employer shall be at liberty and is hereby empowered to deduct the amount of any damage compensation, costs, charges and expenses arising or occurring from or in respect of any such claims or damage from any or all sums due or to become due to the Agency.
- 29. The Agency shall reinstate the system after repairing all damages of every sort mentioned in this clause, so as to deliver up the whole of the contract works complete and perfect in every respect and so as to make good or otherwise satisfy all claims for damages to the property or third parties.
- 30. The Agency shall on demand produce all vouchers/bills to the NIFT for the materials purchased to verify various taxes paid against material for repairing & maintenance including new fittings / materials.
- 31. Water supply and electrical supply will be provided by the NIFT free of cost from the available common convenient points. But the Agency should make his own arrangements for further distribution.
- 32. All the items should be ISI mark/standard make or approved by NIFT's Officials.
- 33. Quoted rate shall be inclusive of the required labour such as drilling, fixing, etc. and required hardware such as pvc, grip, nails/screws, hardware etc.

#### 36. OPENING OF PRICE BIDS

Price bid of only qualified bidders whose technical bid is accepted shall be opened. The date, time and venue of opening of price bids shall be communicated to the technically qualified Bidders of Compliance Bid separately.

#### 37. EVALUATION OF THE BIDS

After the closing time of submission, the eligibility criteria evaluation will be carried out of the responsive bids. The technical bids of the bidders who are complying with all the eligibility criteria will be opened and evaluated next. The price bid of the technically qualified bidders will be opened and L1 bidder will be decided from the Grand Total (including GST) of prices for all items of BOQ. It is mandatory for the bidders to quote their rate for all the items of BOQ contrary to which the Price Bid shall not be considered for financial evaluation and the Agency's Bid thereof will be liable to get rejected. In case of L1 being more than one then deciding criteria for award of work will be tenderer having more no. of years of experience in the Government organizations.

#### **38. PRICE BIDS**

Bidders should necessarily submit their financial bids in the provided **BOQ.xls** file and no other format is acceptable. The prices mentioned in BOQ shall be considered for evaluation and comparison of bids. Bidders are required to download the BOQ file, open it and complete the Blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

- In no case any terms and conditions or technical deviations or any other amendment shall be included in the Price Bid. Any additional options, terms etc. shall be ignored while evaluating the Commercial Bid.
- 2. Price Bid of each item need to be filled. Incomplete / Partial Bid may lead to the rejection of the entire Bid.
- 3. This Price should be all inclusive landed cost at NIFT.
- 4. No claim what so ever shall be entertained by NIFT on account of revision Upward / Downward in the rates of excise duty, sales tax, GST and octroi during the validity of the offer.
- 5. Price shall be inclusive of all freight, forwarding, transit insurance and installation charges if any.
- 6. Prices shall be inclusive of excise duties. The prices shall strictly be submitted in the given format. Quoted prices shall be inclusive of all taxes except GST. The tax components like GST as applicable shall be mentioned separately in the respective columns/rows.
- 7. Payment of materials and service charges including labour work should be made on actual basis
- 8. NIFT will not pay any additional amount over and above the order value. Bidder has to execute the project within the quoted / order value.

#### 39. RESULTS OF THE TENDER

Acceptance of the tender shall be communicated by NIFT in the form of Letter of Intent to the successful Bidder. The successful Bidder shall give the acceptance of LOI in writing to NIFT within 3 Days of issue of LOI /PO, failing which it will be presumed that it has been accepted by the bidder.

#### 40. JURISDICTION

All questions, disputes or differences arising out of, or in connection with the contract shall be referred to the sole arbitrator, appointed under the provisions of Indian Arbitration Act by NIFT. All disputes shall be subject to Gandhinagar Jurisdiction only.

#### **LEGAL TERMS AND CONDITIONS**

- 1. The Agency and his staff must abide by various rules and regulations of NIFT as prevalent from time to time.
- 2. The Agency shall comply with all existing labour legislation and Acts, such as Contract Labour Regulation Act, Workmen's Compensation Act, Minimum Wages Act, Payment of Wages Act, Provident fund Act, ESI Act etc. as applicable. For any lapse or breach on the part of the Agency in respect of non-compliance of any Labour legislation in force during the validity of the contract, the Agency would be fully responsible and would indemnify the NIFT, in case the NIFT is held liable for the lapse on the part of the Agency.
- 3. NIFT would have the right to terminate the contract without notice before the expiry of the term, in case the work performance is not upto the standard, or in case there is any violation of NIFT rules & regulations, or if there is any lapse in compliance of any labour legislation, or if there is any incident of indiscipline on the part of the Agency or his staff. The decision of NIFT's management in this regard would be final and binding on the Agency. In such an event NIFT shall have the right to engage any other Agency from agencies who have participated in the tender and found eligible for opening of price bids to carry out the task on the same rates of ongoing Agency.
- 4. Non-compliance of any terms and conditions enumerated in the contract shall be treated as breach of contract.
- 5. The Agency and his staff shall comply with all instructions and directions of the NIFT authorities given from time to time. In the event of any emergent situation, the staff of the Agency shall comply with instructions given by the NIFT authorities, without waiting for confirmation by the Agency.
- 6. The Agency shall submit to NIFT the list of carpenters / skilled laboures engaged to carry out the contract work, indicating name, age, home address, qualifications etc. and would also intimate as and when any change takes place. The Agency shall not at any time engage a minor to carry out the work under the contract.
- 7. The Agency shall undertake that any act of omission or commission including any loss or damage or theft occurring on account of his staff individually or collectively shall be the sole responsibility of the Agency and further that Agency would compensate NIFT immediately on this account.
- 8. This contract shall remain valid initially for one year and it may be renewed at the discretion of NIFT only in writing on yearly basis for further of two (02) years. Either party can terminate the contract once awarded, after giving one month notice to the other party. Payment will be made within one month of the submission of monthly bill. However, in event of any query, objection or dispute with regard to any bill or a part thereof, the Agency shall not be entitled to any interest to be paid for last payment till such time that the query, objection or dispute is resolved.
- 2. The Agency shall at all times indemnify and keep indemnified the owner and its officers, employees and agents from and against all third party claims whatsoever.
- 3. NIFT will not be responsible for the release of benefits, such as Provident Fund, ESI, Pensioner benefits or allowances to manpower engaged by the Agency.
