a. Earnest Money Deposit (EMD):

Bidders are required to submit EMD of **Rs. 15,000/- (Rupees Fifteen Thousand Only)** in form of Demand Draft in favour of **National Institute of Fashion Technology, Gandhinagar, payable at Ahmedabad / Gandhinagar. - b. Successful bidder's EMD will be retained and it will be adjusted in the performance security deposit. Technical Bid of Tender document without EMD (or) less than the specified amount will be rejected unless any category of Bidder specially exempted by the Government from the payment of EMD, reasons & proof of the same have to enclosed in the Technical Bid.
- c. The Earnest Money Deposit/Security Deposit will be forfeited if:
 - I. Bidder withdraws his tender or backs out for acceptance within prescribed time.
 - II. Successful Bidder fails to remit the Security Deposit.
 - III. Bidder violates any of the condition as specified in the Tender Document.
 - IV. Bidder revises any of the terms quoted, during validity period.
 - V. Work not commenced beyond unacceptable time period as per work order.
- d. Refund of Earnest Money Deposit:

The amount will be refunded to unsuccessful Bidder without any interest after completion of the tender process, and after 60 days of defective liability period.

Eligibility Criteria:

- a. Bidder should have a minimum 3 years' experience in Finishing & Painting work (work order shall be Central/Autonomous Bodies/State Government Department/ Organization / Institution/Autonomous body/PSU/Reputed Organization must be supported with work orders)
- b. The Bidder shall not be under a declaration of ineligibility for corrupt or fraudulent practices or blacklisted by any of the Government agencies.
- c. Average Annual Financial turnover for any 3 years, ending 31st March 2022 (i.e. 2019-20, 2020-21 & 2021-22) should be at least Rs. 5.00 lakhs.
- d. The Firm should have all the necessary Company/Firm registrations of the Govt., PAN Number, GST Registration Certificate and Excise Duty (If applicable) etc. enclose document for proof.
- e. Bidder should have local office in Gujarat State. Bidder should submit documentary Prof i.e. Lease agreement, Electricity/ telephone bill or GST.

- d. Client List in which same nature of work carried out in Government Department/ Organization / Institution / Autonomous Bodies / PSU / Reputed / Pvt. Organization during last three years.
- e. Self-attested copy of PAN card.
- f. Self-attested copy of GST Registration details.
- g. Self-attested copy of income tax return / turnover certificate duly certified by CA with UDIN details in the eligibility criteria.
- h. Company/proprietor profile.
- i. Duly filled, signed and affix the seal in all the Annexure of tender documents such as undertaking, declaration, General information etc.

Scope of Work:

- a. The Successful Bidder shall be responsible to complete the works in all respects and satisfactory performance of complete system.
- b. The Successful Bidder shall be responsible to complete the works before 20 July 2023 (ceiling, wall & external MS railing (G+2) & window Grills of all rooms. including material manpower, tools & Scaffolding work etc. completed or as per direction of Engineer in charge. Submission of the tender implies that these conditions of tender have been read by the bidders and is aware of the scope of the work and they use only quality Materials to be applying as per given in makes Annex.
- c. Work including supplying the painting material as per approved makes /Removing dry OBD, Providing & painting existing painted surfaces with two coats of Asian / Berger make paints of approved colour & shade at all elevations including preparation of surfaces with emery paper & wire brush, washing wherever required, application of putty as required, grinding the surfaces with emery paper to get the smooth & even surface, scaffolding, etc. as directed by authority with all tools & tackles, labour, etc. complete for the following types of the paint:
 - I. Supply of labours for all type of works inclusive of all tools, takes, supervision, labour laws liabilities, workmen compensation, transportation, etc.
 - II. Removing dry or oil bound distemper, rust of the metals, water proofing cement paint and the like by scrapping, sand papering and preparing the surface smooth including necessary repairs to scratches etc. complete.
 - III. Providing & painting existing painted surfaces of walls, ceiling, RCC, etc. with lime/ Colour wash at all elevations including preparation of surfaces with wire brush & emery paper, approved quality glue binder, required quantity of robin blue, screening with fine cloth, applying with brush, scaffolding, etc. as directed by the assigned authority with all materials, labour, tools & tackles etc. complete.
 - IV. Providing & Painting surfaces with one coat of Asian /Berger make cement-based primer.

- V. Providing & Painting surfaces with one coat of Asian /Berger make Epoxy primer
- VI. Providing & Painting exterior surfaces of buildings /walls, etc. with two coats of Asian / Berger make APEX exterior acrylic emulsion paint or Asian / Berger Paints Tractor Emulsion paint of approved colour & shades.
- VII. Asian / Berger make ACE exterior acrylic emulsion paint or Asian / Berger Paints Tractor Emulsion paint of approved colour & shade.
- VIII. Providing & Painting interior surfaces with Geometric shapes in one wall of the each hostel room (total nos. of rooms are 108) and common area of hostel using of Asian / Berger Paints Tractor Emulsion Paint / of Asian / Berger make Plastic emulsion / Acrylic emulsion paint / Asian / Berger Paints Tractor Emulsion paint of approved colour & shade on the other two sides.



Examples of the geometric pattern

- d. Providing & Painting interior surfaces of buildings with two coats of Asian / Berger make Plastic emulsion /Acrylic emulsion paint/ Asian / Berger Paints Tractor Emulsion paint of approved colour & shade (final coat with roller).
- e. Providing & painting existing Doors, Windows, Ventilators, railing, grills, etc. with two coats of Asian / Berger make high gloss synthetic enamel paint of approved shade.
- f. Providing and applying melamine polish to existing polished surfaces of doors, windows, furniture, etc. including preparation of surfaces with emery paper, removing loose materials, applying putty/colour touch-up as per requirement, applying two coats of Asian make melamine over a coat of sealer with spray including protecting grills, fixtures, glass, etc. with all material, tools & tackles, etc. complete.
- g. Providing and erecting separate scaffolding work for specific work requirements as & when required with MS pipe for various heights and removal of the same after completion of work including vertical supports as per requirement.

General Terms and Conditions

1) Bidder shall consider all costs including providing and applying of Painting work at site of NIFT, Gandhinagar Campus etc., In this regard no claim for any extra payment for any reason shall be entertained. Rate is inclusive of all taxes as applicable. The rates should be indicated clearly both in Figures and in words. If there is variation between the rates in Figures and words, the lower value will be taken for evaluation. The rate quoted shall be inclusive of Work, supplying the painting material as per approved makes. The price should be quoted in Indian Rupees.

- 2) Validity of the rates quoted in the Tender will be up to 1 year from the date of opening of the Tender.
- 3) The measurement of painting work may be increase or decrease payment will be based on actual painting work done by agency.
- 4) No escalation of prices in the quoted rate will be allowed under any circumstances.
- 5) Payment will be made based on actual site measurement and quantity certified by building section.
- 6) All Taxes & other charges, if any, should be mentioned clearly.
- 7) Statutory rates are subject to change and will be considered as may fixed by the Government.
- 8) All statutory obligations under various laws, imposed from time to time will have to be met by the contractor for which no extra payment shall be made. NIFT will no way responsible for any default with regard to statutory obligation, if any.
- 9) The contractor shall provide any mode of transport in respect of men or material, tools, equipments etc., required for execution of the work.
- 10) Works shall be executed at NIFT Gandhinagar Campus.
- 11) Bidders should provide the details in the Technical Bid such as company profile, details of all work experience/Company Registration proof etc., of quoted works proposed for providing to NIFT, copy of the work order for similar kind of work. The tender shall be rejected, if any of the above detail is not provided in the Technical Bid, wrong/ false or incorrect information is given in the tender document.
- 12) During evaluation of Technical Bid to consider the Tender, if any clarification on quality standards of the proposed items for supply such as painting materials etc., of the required by NIFT, Gandhinagar, respective Bidder has to submit relevant documents. If required, Bidder has to submit overall satisfactory certificate obtained from Government Department/ PSU/reputed/Autonomous bodies/Pvt. organization where the same proposed Work already Executed etc., and working more than five years.
- 13) If complete information is not given (or) if the particulars and data are not filled in correctly (or) not as specified in the Tender document and may render the bid no responsible and liable to be rejected.
- 14) NIFT Gandhinagar reserves the right to cancel the contract, if unacceptable delay in Commencement of work and which lead to delay in completion of work within given time period and EMD/Security deposit will be forfeited
- 15) NIFT Gandhinagar also reserves the right to cancel the contract before Execution of work, if the supplied Materials are not found satisfactory/As per proposed Make list without giving any compensation to the contractor.
- 16) Price Bids of technically qualified bidders only will be opened. Even after qualifying in Technical bid, the Price bid may not be accepted if found not in order.
- 17) The bid shall remain valid for 90 days from the date of opening of the Price Bid. Validity beyond 90 days from the date of opening shall be on mutual consent.
- 18) In case of L-1 is more than one, the selection criteria (viz. the past performance, experience, turnover, etc.) would be at the discretion of NIFT. The decision of NIFT, Gandhinagar in this regard and for selection of successful bidder in such situation, will be final in all respect and will be binding on all the Bidders. Lowest bid may not be the only criteria for selection and NIFT is not bound to issue work order to the agency being the 'L-1' bidder; weightage/ preference will also be given to the other factors such as in Price Bid filled detail is not in order, any difference of technical details given by the Bidder in the Technical Bid and price Bid etc., and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the Bidders.

- 19) The said Interior and exterior painting work at NIFT Gandhinagar campus should be completed on or before 20.07.2023 failing which a penalty @0.1% of the order value per day will be imposed subject to a maximum of 10% of the Order Value. However, delay in Execution due to any applicable/ unforeseen reason, viz. natural calamity, non-availability of site, etc., may be considered as may be decided by NIFT Authority Beyond 45 days of delay Security deposit will be forfeited and NIFT, Gandhinagar would be free to award remaining work to other agency at the cost of Contractor.
- 20) The Committee constituted by the Competent Authority, NIFT, Gandhinagar shall have the right to verify the particular furnished by bidder. Those technically qualified bids will only be considered for price evaluation (Price Bid). Price should not be quoted with Technical bid; otherwise the tender will be rejected without any correspondence. Decision of the Director, NIFT Gandhinagar on the eligibility for qualifying technical bids shall be final and no representation shall be considered in this regard.
- 21) NIFT reserves the right to change the quantity/drop any item or part thereof/change in the scope of work and the bidder shall have to supply the items and execute the work at the same Rate per unit as mentioned in their Price bid.
- 22) Work awarded contractor should depute only competent and experienced staffs in the same nature work to carry out the work.
- 23) The contractor shall depute only competent and experienced staff in the same nature work to attend the defect/Rectification, if any, during warranty period.
- 24) The Director, NIFT Gandhinagar reserves the right to accept the whole tender or any part thereof or reject all the tenders, in the interest of the NIFT so require, without assigning any reasons whatsoever and to waive any minor discrepancy in the tenders received and if performance of the bidder during the execution of work found unsatisfactory
- 25) Any query/ clarification with respect to the tender (Terms and conditions, specification(s), etc. contact Concerned NIFT Gandhinagar official at (079-23265017) during working day between 10.00 a.m. and 5.00 p.m. or instruction of Engineer In charge and get cleared prior to submission of tender.
- 26) The contractor should provide all the safety equipment and tools, testing equipment etc., required to carry out the work.
- 27) It is sole responsible of the contractor to ensure the safety of the user and if there is any loss to the Institute on account of dishonesty, and or due to any lapse on the part of the contractor.
- 28) In case of any accident (or) damage due to negligence or unsafe work that require immediate medical attention, the contractor is wholly responsible.
- 29) NIFT shall not be responsibility for death/injury or accident to the contractor's employee which may arise / arising out of and in the course of their duties.
- 30) Force majeure clause applicable as per Government norms.

Performance Security Deposit:

a. EMD will be converted into Performance Security of successful bidder which will be retained for liability period of 01 year from the date of completion of work and deduction, if any as applicable. Security Deposit will be refunded/ returned, without any interest, after completion of defect liability period of 01 year from the date of completion of work and deduction, if any and as applicable. The whole amount of the Performance Security Deposit shall be liable to be forfeited in case of breach of any of the terms agreed upon by the contractor. Refund of Security Deposit will be after completion of the contract period and defect liability period of 60 days beyond the contract period.

- b. The material shall be inspected on receipt at site i.e. NIFT, Gandhinagar. If any of the material is not in order / defective (or) specification as per the work order (or) material is not suitable, the contractor should replace the material without any additional cost and the contractor shall be responsible for any damage during the transit of goods.
- c. If any defective/deviation in the work during execution, the contractor should rectify the same without any additional cost.

Payment Terms:

- a. Payment will be made as per actual site measurements and released against original invoice after verification of the work and certification of satisfactory completion of the work by the respective NIFT Authority.
- b. No interim payment will be made on the delivery of the materials.
- c. Statutory recoveries (TDS, GST etc.) if applicable will be deducted from the invoice amount as per Rules.
- d. No payment shall be made in advance. The payment shall be made after completion of works and on the basis of certification by the concerned NIFT Official(s). TDS etc., if any and as applicable, will be deducted during payment.
- e. Payment will be made based on actual site measurement quantity on due certification of work by Building Section.


