A statutory Body governed by NIFT Act 2006 and set up by the Ministry of Textiles Government of India.**

1. TECHNICAL QUALIFICATION CRITERIA:

The Tenderer must fulfil the following eligibility conditions:

1. Tenderer sales turnover should not be less than **Rs.3 Lakh (Rupee Three lakh) per annum** in the last two years (F/Y 2017-18 & 2018-19). (Documentary proof to be attached)
2. The Tenderer firm should possess PAN Number and should have all the necessary registrations of the Govt. under the Shops and Establishment Act, Registrations under GST etc (wherever applicable) etc. (enclose the documents)
3. A separate **Demand Draft / Pay Order of Rs.500** (non – refundable) drawn in favour of NIFT Kangra payable at Kangra against E-Tender document cost shall be attached with technical bid in case the E-Tender document is downloaded from the website www.nift.ac.in, E-Tender received without the Tender document fee will be rejected.
4. **The technical bid should be accompanied by a bank demand draft/pay order of Rs 75,000/- (Rupee Seventy Five Thousand Only) in favour of NIFT Kangra as Earnest Money Deposit (EMD).**
5. The Tenderer should provide Defect Liability for a period of minimum one year from the date of supply / installation at NIFT Kangra Chheb.
6. **The Corrigendum if any will be published over the website of the Institute. The Tenderer should keep watching the website of the Institute for Corrigendum if any.**

4. DUE DATE & TIME

The sealed E-Tenders should reach the office of the Joint Director NIFT, Kangra on or before the due date and time as mentioned in the E-Tender notice. The E-Tenders will be opened at **07/12/2020 at 3 PM.** If the last day happens to be a holiday, the E-Tender will be opened at the next working day at the same time. The E-Tender received after due date and time or unsealed or incomplete or by electronic mail will be summarily rejected.

5. COST OF E-TENDER DOCUMENT

The cost of the E-Tender document is Rs.500/- (Rupees Five Hundred only). The same can be obtained by paying the fees through demand draft/banker's cheque drawn in favour of NIFT Kangra, payable at Kangra. The E-Tender document is not transferable to any other bidder.

6. **EARNEST MONEY DEPOSIT**

- A. Tenderer shall enclose a demand draft/pay order of any scheduled bank for an amount Rs 75,000/- in favour of NIFT Kangra, payable at Kangra as the non-interest-bearing Earnest Money Deposit along with technical bid. The technical bid without EMD shall be rejected.
- B. Cheques and bank guarantees will not be accepted towards EMD.
- C. On opening technical bid envelope if it is found that EMD is not enclosed, then the E-Tender offer will be summarily rejected unless any category of Tenderer is specially exempted by the government from the payment of EMD for which reasons and proof have to be enclosed.
- D. The EMD will be forfeited if:
 - i. Tenderer withdraws his E-Tender or backs out after acceptance.
 - ii. Tenderer fails to remit the security deposit.
 - iii. Tenderer violates any of the conditions prescribed in the E-Tender document.
 - iv. Tenderer revises any of the terms quoted, during validity period.

7. **REFUND OF EARNEST MONEY DEPOSIT** EMD shall be refunded to the unsuccessful tenderer, after the selection of L-1 bidder and issuance of work order

8. **Time Schedule**

Time schedule for completion of work is 30 days from the date of award letter.

Sealed tender should be in lump sum basic price (inclusive of all duties / taxes) Tender should be inclusive of all kinds of expenditure towards all material, transportation, labour etc and any other related expenses. **No advance payments shall be applicable.**

- TDS will be deducted at source at the time of release of payment. The Contract amount as per this schedule shall only be paid in favour of the quoting firm only. If made applicable the GST TDS will also be deducted.
- The entire operation must be done within a maximum period of 30 days or earlier.
- The Contractor should be business of construction for at least last 02 year and shall have the scope for Construction of similar kind.
- The firm shall deposit an earnest money amounting to Rs. 75,000 (Rupees Seventy Five Thousand (Only) along with tender Bid in the form of Demand Draft in favour of NIFT, payable at Kangra & drawn on any of the commercial banks which will be re-fundable after finalization of tender.
