INTRODUCTION:

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 16 centres. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and short duration education program to address the specialized needs of professional and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Panchkula, Raibareli, Shillong and Srinagar.

Expression of interest is invited from professionally qualified and interested service provider for Augmented Reality enabled batch book.

OBJECTIVE

NIFT intends to publish Augmented Reality enabled batch book for the passing out students of batch 2020, totalling to around 180 students in all.

The batch-book contains profile, project details, and interests of the passing out students, with around one page devoted to each

Requirements are as follows

The requirement is to augment the batch book with video presentation and 3D representation of the student's work, conducted during her tenure at NIFT Kangra. The final deliverable shall contain one mobile application each for (a) Android and (b) iOS platforms.

The mobile application shall have the following features

The application may allow the user to view the batch book through the phone camera in the hand-held mode.

The application should be capable of showing 3d models of the work done by the students on the page of the respective student.

The application should also be capable of displaying 2D video (prepared by the student) on the respective student's page on the press of a toggle button.

The vendor shall be required to prepare 3D models of the artefact (prepared by the students) which needs to be augmented on the batch book, in coordination with the committee so formed by the college for this very purpose.

Following qualifications shall be a plus for the vendors Prior publication of AR/VR book.

Prior projects in AR/VR space.

Original Equipment Manufacturer for AR/VR related equipments Software Service turnover of Rs 1 crore or more in any of the preceding two financial years, Or registered as start up under DPIIT.

Complete ownership of the AR/VR book will be retained by NIFT Vendor should provide support for 15 months from the date of deployment Charges including hosting charges in Apple/Play store has to be indicated clearly Vendor should sign a Non-Disclosure Agreement for copyrights and confidentiality

The eligible organisation/agencies/individual interest in rendering their service as per above may submit EOI in sealed envelope, superscripting the tile õEOI Augmented Reality enabled batch book for NIFTöat National Institute of Fashion Technology Kangra Camus.

The timeline for developing, supply and installation of AR/VR book in within 10 days from receipt of the required data.

Payment will be released after supply and installation of AR/VR book.

The GST TDS and TDS will be deducted as per norm.

The financial bids need to be placed in separate enveloped and sealed while placing along with other documents of EOI. All documents needs to be submitted together.

Corrigendum if any will be published over the website of the Institute. EMD of Rs 10,000 to be submitted along with Technical Bid will be adjusted against the Performance Security in case of Successful Bid. In case of Unsuccessful bidder EMD will be returned.

Performance security will be 5% of the total bid value.
