NOTICE FOR ALLOTMENT OF GIRLS' HOSTEL SEATS AT NIFT KOLKATA

NIFT Kolkata provides accommodation facilities to the girls' students with limited beds which are being allotted through lottery among the interested candidates.

Lottery for Girls' Hostel seat allotment for the interested candidates who have taken Admission in the year 2018 will be held on 23rd July, 2018 from 10.00 am onwards at NIFT Kolkata Auditorium.

Interested candidates are advised to be present on 23rd July, 2018, 10.00 am sharp at NIFT Kolkata Auditorium alongwith the following mandatory documents for booking of Hostel seats:

- i) Application Form in the prescribed format to be written by hand by the candidate [Please note that the details alongwith photograph of Local Guardian is mandatory for availing Hostel Facility]. Application form can be downloaded from NIFT Kolkata website, <https://www.nift.ac.in/kolkata/>
- ii) Demand Draft of Rs.70,250/- [Rupees Seventy Thousand Two Hundred and Fifty only] for booking of Non AC Rooms and Rs.90,250/- [Rupees Ninety Thousand Two Hundred and Fifty only] for booking of AC Rooms to be made in favour of **NIFT HOSTEL A/C (No. 607602050000033) payable at Kolkata.**

The candidates who have submitted Demand Draft for AC Rooms and subsequently take booking in the Non AC rooms (due to non availability of AC Rooms) will be refunded the differential amount within 48 hours. However, candidate who is willing to book AC Room seat shall have to submit the demand draft of Rs.90,250/- on 23rd July, 2018 at the time of lottery. Relaxation of the same will not be entertained.

Further, in connection with the booking of Hostel, please note that allotment of AC / Non AC Rooms is purely subject to lottery and availability. Before submission of application form, all the concerned are advised to go through the Rules and Regulation of Hostel facility carefully for strict compliance in future since non compliance will lead to disciplinary action.

It may also be noted that mere submission of application form does not entail a candidate to claim right for booking of hostel facilities. The decision of the Hostel Committee and the Campus Director shall be final and binding.
