The terms and conditions of the tender are as follows:-

TENDER NOTICE

Tenders are invited from reputed agencies/contractors for providing "TENDER FOR FULLY COMPREHENSIVE ANNUAL MAINTENANCE CONTRACT OF FIRE FIGHTING SYSTEM (FIRE HYDRANT, FIRE ALARM & DETECTION AND PUBLIC ADDRESS SYSTEMS) AT NIFT CAMPUS, PLOT NO.15& 20, SECTOR-4, KHARGHAR, NAVI MUMBAI- 410210". The Earnest Money in the form of Demand Draft/Pay Order should be after the date of publishing of tender date, payable in favour of "NIFT Mumbai.

- 1. NIFT shall have the authority to cancel the tender process if NIFT does not find a suitable tender. NIFT shall have the right to call for fresh tender in such circumstances, wherein tenderers who have bid in the previous tender, shall have the right to participate in the fresh process. The tenderers shall have no right to challenge the authority and decision of NIFT to cancel the tender process for the reasons deemed fit by NIFT.
- 2. The location & equipments can be inspected any time during working hours on any working days. No extra money shall be payable by NIFT for non awareness of the site conditions and constraints.

(II) Guidelines for Submission of Bids

- (b) Applications to this tender will be accepted only through the online mode. No other mode of application will be considered & application will not be accepted.

- (c) The technical bid must contain the technical bid in prescribed Proforma as per (Annexure-I) and Earnest Money Deposit (refundable but non-interest bearing) of Rs.35,000/-(Rupees Thirty Five Thousand Only) favoring National Institute of Fashion Technology and payable at Mumbai with all relevant documents in support of eligibility. The bids duly-filled in all respects enclosing necessary documents may be addressed to the Director, National Institute of Fashion Technology, NIFT Campus, Plot No. – 15, Sector – 4, Kharghar, Navi Mumbai – 410210, so as to reach **on or before 03:00 pm, 24/06/2021** or the tender may be dropped in Tender Box placed at the Reception Area of NIFT, Mumbai Centre.

GENERAL TERMS AND CONDITIONS

- 1. Please read the Terms & Conditions carefully before filling up the document. Incomplete Tender Documents will be rejected.
- 2. Before submitting the tender, details of documents to be attached may be verified from the Check List given in Technical Bid of the Tender Document.
- 3. The Technical bid should contain Earnest Money Deposit of an amount of Rs. 35,000/- in the form of bank Demand Draft in favour of NIFT, payable at Mumbai. This Earnest Money Deposit (EMD) will not bear any interest. Tender document without EMD shall be rejected.
- 4. A separate Demand Draft/ drawn in favour of NIFT Mumbai payable at Mumbai against Tender document fee shall be attached with technical bid, in case the tender document is downloaded from the website. **THIS DEMAND DRAFT IS REQUIRED TO BE SUBMITTED WITH THE TECHNICAL BID.** Downloaded Tender Documents submitted without demand draft towards the cost of Tender Document shall be rejected.
- 5. The Tenderer must write the name & complete postal address of the bidding firm on the back side of the Demand Draft(s).
- 6. All pages of the Tender Document must be signed by the authorized signatory and sealed with the stamp of the bidding firm as token of having accepted all the Terms and Conditions of this Tender.
- 7. The decision of the Institute in this regard will be final and binding on all bidders.
- 8. Tender shall be submitted in NIFT's official tender form only. If submitted in any other manner, the same shall be summarily rejected. No bidder shall be issued more than one Tender Form.
- 9. Tenders received without the prescribed Earnest Money Deposit (EMD) of **Rs.35,000/**-(Rupees Thirty Five Thousand only) shall be rejected.
- 10. No paper shall be detached from the Tender Document.
- 11. The name and address of the bidder shall be clearly written in the space provided for the purpose and no over-writing, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the bidder. The tender should be filled in

and submitted strictly in accordance with the instructions contained herein; otherwise the Tender is liable to be rejected.

- 12. The Financial bids submitted by all bidders should be valid for at least for a minimum period of three months from the date of opening of Technical Bids.
- 13. Person signing the bid or other documents connected with tender must clearly write his/her name and also specify the capacity in which signing.
- 14. The Institute reserves the right to reject any or all the tenders without assigning any reason thereof.
- 15. Before submitting the filled-in Tender Document to the Institute, the bidders may seek clarification(s), if any, from Administrative Department on Tel. No. 022-27747103, 7008, 7000 **OR** in person by visiting the Institute during working hours by intimation.
- 16. The Institute reserves the right to change any condition of the tender before opening of the Technical Bids.
- 17. The quality of work at all stages should be as per the standards laid down and explained to the Bidder by NIFT, Mumbai. It is made clear that there cannot be any compromise in the material quality and workmanship of work. It shall be the responsibility of the Bidder to ensure that the standards laid down from time to time are strictly maintained.
- 18. The Bidder should obtain the requisite license for running the establishment from authorities such as Municipality, Local Authority, State/Central Government etc., at its' own cost. The NIFT shall not be responsible in any way for any breach of these rules and regulations by the Bidder
- 19. The Bidder shall not deploy any person below the age of 18 years.
- 20. The successful bidder will have to enter into an agreement with the Institute.
- 21. Canvassing in any form will make the tender liable to rejection.

DUTIES AND RESPONSIBILITIES OF THE BIDDER:

- 22) The Bidder shall carry out all work with utmost care, giving due consideration to safety which shall not be compromised under any circumstance. It will be responsibility of the Bidder to promote an electrically safe workplace free from unauthorized exposure to electrical hazards for all its employees and outsourced personnel so as to prevent accidents to themselves, the public (community) and the NIFT's property.
- 23) The Bidder shall be responsible for taking good care of all specialized equipments, tools and tackles used for its works. It should bring to the notice of the NIFT the works that are required to be undertaken in time. In case any damage is caused to the equipment's due to the gross negligence of any of the employees of the Bidder,

Bidder undertakes to indemnify the NIFT for such damages. The amount of damages quantified at the discretion of the NIFT Engineer shall be final & binding on the Bidder. The NIFT shall be at liberty to deduct such amount of damages from any dues payable to the Bidder

- 24) The Bidder shall not assign the contract or sublet any portion of the contract. In case of breach of this condition, NIFT will serve a notice in writing on the Bidder rescinding the contract where upon the security deposit/performance bank guarantee shall stand forfeited to NIFT without prejudice to other remedies against the Bidder.
- 25) The employees deployed by the successful Bidder should observe the discipline and should see that the decency and decorum are maintained within the course of their employment. He should submit their police verification to NIFT.
- 26) The Bidder should furnish the monthly, quarterly and yearly maintenance schedule in consultation with Engineer In-charge, within seven days time after getting work order.
- 27) All personnel employed by the Bidder shall be medically fit and having good health.

ELIGIBILITY CONDITIONS/GUIDELINES FOR EVALUATION OF TECHNICAL BIDS FOLLOWINGS ARE THE QUALIFYING CRITERIA:

- 1. The bidder must submit a self-attested copy (copies) of Recent work order (s) (details filled with attached format Annexure-V) of which the work (s) has (have) been completed within last seven years as on tender opening date as a proof of similar work done in a PSU, Central/State Government Organization or subsidiary/Joint venture/Regulated company thereof, or a reputed private company etc.
- 2. The bidder must have carried out similar nature of works of Government/MNC/PSU etc.
- 3. The bidder should have office in Mumbai.
- 4. The vendor should have been in the field of maintenance of fire & safety work during the last 3/4 years.
- 5. The vendor should be a valid Govt. Fire & Safety License and registered dealer/distributor for supplying of reputed brand of Fire & Safety materials.
- 6. Annual Gross Turnover during the last 2 years should be minimum 25 Lakhs in each financial year.
- 7. The tenderer & those bidders who does not fulfill above eligibility criteria will be rejected.

OPENING OF BIDS:

- 1. The online Technical Bids will be opened on 25/06/2021; 3.30 pm at National Institute of Fashion Technology, Plot No.15, Sector-4, Kharghar, Navi Mumbai in the presence of such bidders who may wish to be present, either in person or through their authorized representatives (duly supported with authorization letter).
- 2. The online Financial Bids of only technically acceptable tenders will be opened for further consideration. The decision of the Institute in this regard will be final and no requests etc. will be entertained from the bidders. The date and time of opening of financial bid(s) will be intimated only to such bidders who are found eligible as per evaluation criteria prescribed by the Institute.
- 3. EMD of the unsuccessful bidders will be returned without interest, after finalization of contract.

EVALUATION OF FINANCIAL BIDS

From among the bidders short listed after the evaluation of the Technical Bid, the Lowest 1 Bid will be decided at the time of finalization of tender on the basis of rates given in the Financial Bid for Fully Comprehensive Annual Maintenance Contract of Fire Fighting Systems at Plot no. 15 & 20, Sector – 4, Kharghar, Navi Mumbai – 410 210.

PERIOD OF CONTRACT

- 1. Initially contract will be awarded to successful bidder for period of one year and based on the performance and services rendered may be extended for further period of 1 year with same rate, terms and conditions.
- 2. The one year contract period is subject to renewal by the Institute on satisfactory performance, no contract will be extended beyond 3 years under any circumstances.

FORFEITURE OF EMD

EMD of the successful bidder shall be liable to be forfeited if the contractor does not fulfill any of the following conditions:

- i. An agreement is not signed in the prescribed form within ten days of the receipt of the Letter of Award of the Contract;
- ii. The Contractor does not commence maintenance services within seven days of the stipulated date for commencement of maintenance services.
- iii. As per the agreement the contractor should complete the AMC work during the AMC period properly and satisfactorily, if not completed the contract period during the AMC period the EMD shall be liable to be forfeited.

The Contract for award of "Fully Comprehensive Annual Maintenance Contract of Fire Fighting Systems installed at plot no. 15 & 20, Sector-4, Kharghar". In view of this, no change in the financial bid will be allowed. If the successful bidder withdraws or alters the terms of the tender during this period, the Earnest Money Deposit shall be forfeited.

SECURITY DEPOSIT

1. The contractor shall be required to deposit an amount equivalent to 5% of work amount as security deposit immediately on acceptance of Work Order in the form of demand draft of nationalized bank/schedule bank only in favour of NIFT, Mumbai payable at Mumbai. The Successful bidder EMD Deposit may be converted in to security deposit. No interest shall be paid on such security deposit, which shall remain with the Institute

In order to ensure 100% serviceability for efficient working of the equipment under contract the scope of work will include the following.

(Note: The below mentioned scope of work shall also be applicable in case of Fully Comprehensive AMC)

- 1. The servicing & random checking of fire hydrant and detection system shall be done periodically invariably.
- 2. The system shall be kept in working condition till the completion of contract. The firm will arrange handing over of the total system in full functional condition on completion of contract.
- 3. In case of emergency, the firm shall give full support for mitigation of fire accident at no extra payment.
- 4. Each Pump should be tested for at least 60 second every visit. Discharge of water should be from Hydrant or through a test line. Unnecessary sound and vibration should be noted and corrected. (Monthly Basis)

- 6. Greasing of pumps and motors to be carried out as per manufacturers recommendation or whenever necessary. (Monthly Basis)
- 7. Hydrant externally and terrace shall be tested with hose and branch pipe. The jet shall be operated for at least 2 minutes. Hose shall be dried before rolling. (Monthly Basis)
- 8. First Aid Hose Reels shall be tested by swinging it on its support and partly opening the hose and discharge of water for 60 seconds. Each Hose shall be tested. There shall be no leakage from MS piping or from clips holding rubber or even from rubber pipe. Hose pipe shall be rolled back uniformly, line by line. (Monthly Basis)
- 9. First Aid Hose Reel shall be extended to full length and water discharged for 120 seconds. The pipe shall be rolled back uniformly, line by line. (Monthly Basis)
- 10. Internal Hose Cabinet shutters (including glass) shall be cleaned every visit. Dust and dirt within cabinet shall be removed in every visit. (Monthly Basis)
- 11. Hydrant on each floor shall be tested with hose and branch. The Agency shall make all arrangements for disposal of water in the premises so that there is no damage. (Monthly Basis)
- 12. Replacing of gland packing/seals in various pumps and valves on as and when required to ensure that there is no leakage.
- 13. Checking of electrical terminals, contact points of the starters/contractors and relays installed in various control panels

- 14. The contractor shall not dismantle and remove any items without the knowledge of the Engineer In-charge. Dismantled items shall be the property of the NIFT Mumbai.
- 15. Contractor will visit the site as and when called by the Engineer In-charge. On his visit he should meet the Engineer In-charge and will report about satisfactory working of all equipment's
- 16. The contractor will be responsible not only for his own men and material but also for the security of the equipment/materials of the NIFT. The cost of repair/replacement of equipment damage due to mishandling by the worker of the contractor will be deducted from the contractor's bill after loss assessment by the Workshop In-charge. The assessment of the Workshop In-charge will be final and binding on the contractors.
- 17. Arranging all major components requiring repair/replacement/refill with prior consent and approval of the authorized Engineer In-charge. All cost of the components along with the procurement with all taxes shall be included in the rates of CAMC.
- 18. The contracting Bidder shall guarantee prompt repairs/replacement/refill of components to minimize interruption. In all probability the Bidder will be required to arrange repair and replacement/refill of such damaged components the same day or reasonable time as per situation.
