1. Last date of depositing the Hostel fee for July 2018 to Dec 2018 is **10<sup>th</sup> September 2018**. Fee with a late fine of Rs. 100/- per day can be deposited till **20<sup>th</sup> September 2018**.

The Hostel Fee may be deposited through Demand Draft in Favour of "NIFT, Patna", payable at Patna or through the Cash Deposit Challan of Union Bank of India in any of the nearest Union Bank of India Branches. All the details are to be filled and Accounts copy of the same must be deposited to the Accounts Department of NIFT Patna.
3. The Hostel Fee can also be deposited through NEFT/RTGS, (Bank A/c no:-529602050021024, A/c Name-NIFT PATNA HOSTEL ACCOUNT, IFSC code :- UBIN0574236, BRANCH:- NIFT Mithapur Patna). However, the student has to mandatorily submit transaction details in the prescribed format along with transaction receipt. The format is uploaded on the website with circulars.
4. Hostel Fee payment through CMS will be introduced shortly. Updated Circular will be issued in this regard.
5. Non-payment of the hostel fee latest by **20<sup>th</sup> September 2018** [with late fine] the name of the student will be struck off from hostel register without any further notice.
