Deptt. or who have executed civil works in Govt. deptt ,PSUs, Government Institutes/bodies.
- The interested bidders should apply online and submit their tender and bids along with scanned copy of all the relevant certificates and documents etc. in support of technical and price bids duly signed- on the https://nifttenders.eproc.in till 14.00 Hr. on 16.01.2020 PM E-tender document is also available for viewing on the "tenders" link of the NIFT website i.e. https://nifttenders.eproc.in and /https://nift.ac.in/raebareli.
- 3. The Tenderers are requested to read the instructions in the e-Tender; Terms and conditions carefully before quoting the rates in quotations / Tender Schedule and comply with the same there after amendments made if any.
- 4. Application to this tender will be accepted only through the online mode https://nifttenders.eproc.in. No other mode of tender shall be considered as such tender shall not be accepted.

Basic Requirements

The basic requirements for registration and applying for tender online are as under:

Always use Class III B Digital Signature Certificates (DSC) having Signing and Encryption both.

- 6. In case, the tender document not received online in prescribed format and/or found incomplete in any respect, the tender offer will be summarily rejected.
- 7. Only the Technical Bids will be opened on the date of online tender opening. Price bids of only those bidders will be considered for opening whose offer is complete and technically acceptable in all respects.
- 8. The name and address of the tenderer shall be clearly written in the space provided in e-tender. The tender should be filled in and submitted in strict accordance with the instructions laid down here in; otherwise the tender is liable to be ignored.
- 9. The tender is liable to be ignored if complete information is not given there-in, or if the particulars and data (if any) asked for in the Schedule to the tender are not filled in.
- 10. Offers received without earnest money or with earnest money less than the amount specified above shall be summarily rejected and online tender will not be opened whose EMD not received before due date and time of opening of tender.
- 11. Firms claiming exemption from depositing earnest money must enclose copies of their registration details validity as on the date of tender opening along with all its amendments for the subject stores. Offers received without these details and without earnest money will liable to be ignored.
- 12. The Earnest Money of the successful tenderer shall be returned after the security deposit as required in terms of tender is furnished by the tenderer. The Earnest Money to other than lowest bidders will be returned after finalization of the L-1.
- 13. The Earnest Money deposited is liable to be forfeited if the tenderer withdraws or amends impairs or derogates from the tender in any respect within the period of validity of his tender. If the successful tenderer fails to furnish the security deposit as required in the contract within the stipulated period, the EMD shall also be liable to be forfeited by the Purchaser.
- 14. Dispute, if any, arising out of the supply of Items shall be settled by mutual discussion and Director, NIFT Rae Bareli decision will be final and binding upon both the parties.
- 15. Tender shall be accompanied by the relevant documents covered in the tender.
- 16. Prices may be quoted for the items as per annexure "B" of Price bid.

- 17. The rates quoted should be on FIRM & FIXED basis.
- 18. The NIFT is registered with the DSIR for the purpose of availing customs duty exemption in terms of Govt. Notification No. 51/96-Customs and Central Excise duty exemption in terms of Govt. Notification no. 10/97-Central Excise as amended from time to time. The duty charges to be paid accordingly in case of imported items.
- 19. Bidder must be registered for GST, PAN etc. and should enclose copies of relevant certificates
- 20. NIFT, is statutory Institute under NIFT Act 2006, governed by the Ministry of Textiles, Govt. of India. The equivalent will be used for educational purpose, if any educational discount is applicable, may be mentioned clearly in price bids.
- 21. Tenderer must have to quote each and every item given in the tender, the consolidated rates will not be considered and tender will be rejected.
- 22. The supply order will be issued to the bidder on the basis of overall total quoted lowest price.
- 23. NIFT Raebareli reserves the right to change the quantity/drop any item or part thereof at any time before placing the work order.
- 24. A penalty as decided by the Competent Authority of NIFT for the items shall be payable & the same shall be deducted from his bill or security deposit as the case may be, for any defect in the work later on during the currency of warranty not set right or for non compliance of any terms & conditions other than time clause by the supplier.
- 25. National Institute of Fashion Technology reserves the right to accept or reject any or all the offers either fully or partly without assigning any reason
- 26. In case of any doubt during technical evaluation, clarification may be sought by NIFT after the approval from the competent authority.
- 27. MSME and Startups Organization participating in the tender are exempted from depositing EMD. Firms claiming exemption from depositing earnest money must enclose copies of their registration MSEs/MSME details validity as on the date of tender opening along with all its amendments for the subject stores. Offers received without these details or without earnest money will liable to be ignored.

General Terms and Conditions

- 1. The rates shall include cost of labours & material for the works complete in all respects.
- 2. The quoted rates shall include all taxes, and GST as applicable and no extra shall be payable on this account.
- 3. Rates shall be valid for three months from the date of opening of tender.
- Water and Electricity will be provided free of cost at one point for bonafide use.
- 5. Work shall be completed within 120 days after issue of the work order.
- 6. The selected contractor/agency shall have to furnish one year guarantee against any defects/leakage. The sample and brand must be approved by NIFT before commencement of the work.
- 7. Works are to be carried out as per CPWD specifications.
- 8. Security deposit @ 1% of the gross amount of each running bill till the sum along with the sum already deposited as earnest money will amount to security deposit of 5% of the tendered value of the work. The security deposit shall be collected from the running bills of the contractor at the rates aforementioned and the earnest money deposited at the time of tenders will be treated as part of security deposit. The same shall be released after completion fifteen month from the date of handing over of completed work.
- 9. The payments shall be released against submission of R.A. bills by the contractor at stages of work. The stages to be decided in consultation with the Engineer-in-charge. The final payment shall be released as per actual measurement of works for the work actually executed and accepted by the Engineer-in-charge.TDS (GST/IT) will be deducted as applicable.
- 10. If the performance of the contractor is not found satisfactory and not corrected within 15 days of receiving notice, then NIFT shall be at liberty to terminate the contract and get the work executed through other means at the risk and cost of the Contractor. In the event of termination of the contract, NIFT shall be at liberty to get balance work done at the risk and cost of the contractor and due payment of the contractor, if any, shall be released after the completion of whole of the works.
- 11. If the contractor fails to maintain the required progress of work or fails to complete the work by the stipulated / extended date of completion then the delay damages shall be levied @ 0.5% of the tendered amount per week, subject to a maximum of 10% of the tendered value.
- 12. Any dispute arises out of this tender is subject to the jurisdiction of Rae Bareli Court only.
- 13. Payment will be made through NEFT only. The required information for making payment through NEFT duly vetted by your banker along with the invoice.
- 14. NIFT has reserved the right to accept or reject the offer fully or partially without assigning any reason.

- 15. Approval for the drawings and sketches, if necessary including those of the plant and machinery that would be used their locations arrangements for conveying and handling materials etc. should be obtained from Engineer incharge well in advance for each item of work.
- 16. No escalation /Variation on the prices on any account will be considered for adjustment/payment,
- 17. The bidder shall inspect the site of work and thoroughly familiar himself with the nature of work, site conditions and access to the site and location before submission of the tender.
- 18. Proper care should be taken to provide adequate protection to the existing structures and cables (Telephone, computer etc), all such installations against any damage/defect to the existing structure arising due to faulty execution of work shall have to be rectified as directed to the satisfaction of Engineer In Charge without any extra charges.
- 19. Quality control: Regular appraisal of the quality control to the Engineer in charge should be made for effective improvement in the construction techniques to ensure satisfactory quality of work.
