Sub: Academic Fee Structure for Non NRI Students for the session Jan to June, 2021 (UG & PG Batch)

The details of the fee applicable to the students for the session January to June, 2021 are mentioned below:- The Students shall pay the applicable fee as per the schedule:-

The students are requested to pay the applicable fee as per the schedule mentioned below:-

1. Last date of depositing the fees for the session January to June, 2021 is **8th February, 2021**. Fee with a late fine of Rs. 100/- per day can be deposited till **19th February, 2021**.
2. The name of the student will be struck from the institute rolls without any further notice in case of non-payment of fee after the specified date.
3. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence are requested to contact their respective department before the commencement of the session to complete the formalities. Repeat students will be required to pay the revised re-registration fee of Rs. 10,000/- + 18% GST = **Rs. 11,800/-** per absenting semester as well as non-refundable annual charges towards Library and Student Development & Medi-claim fee over and above mentioned amount.
4. The Hostel Fee circular will be circulate separately, in case applicable.

Demand Draft for Academic Fee may be drawn in f/o NIFT payable at “Raebareli” only. The student may also deposit their Academic Fee through RTGS/NEFT. The details for online fee transfer are mentioned below:-
