INTRODUCTION:

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in field of Fashion Technology. NIFT provides fashion business education across the country through its network of 17 centers. It provides four years under graduate (UG) program in design and technology, two years post graduate (PG) program in design, fashion management & fashion technology and short duration education program to address the specialized needs of professional and students in the field of fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Raebareli, Shillong Srinagar and Panchkula.

General terms & Condition

- 1 Offer shall be submitted in official tender form as per given Annexure only. If submitted in any other form the same shall be summarily rejected.
- 2 The offer should be valid for at least 3 months from the date of opening of the tender.
- 3 Correction if any must be attested.
- 4 National Institute of Fashion Technology reserves the right to accept or reject any or all the offers either fully or partly without assigning any reasons and is not bound to accept the lowest bid since due weightage shall be given to several factors besides the commercial bid.
- 5 Payment shall be made quarterly on satisfactorily completion of the job, certified by Engineer in charge of NIFT Rae Bareli and TDS as applicable will be deducted. No advance payment will be made to the party.
- 6 The Contract covers attending to any number of breakdown calls and four comprehensive maintenance services in a year during the tenure of the contract apart from preventive maintenance.
- 7 Any part required for proper functioning of RO's including membrane, filter and other parts (Electrical & Mechanical) which require repair /replacement due to normal wear and tear during the contract shall be replaced free of cost.
- 8 Party has to submit the bank guarantee/FDR/DD from nationalized bank in favor of NIFT Raebareli which will be 10 % of quoted annual value of the contract and the validity of the bank guarantee/FDR/DD is **fifteen months** from start of the contract as performance security amount.

- 9 All statutory obligations under various laws from time to time will have to borne by the contractor and for which no extra payment shall be made to him at any time during the contractual period.
10. After completion of the contract, contractor has to hand over the systems in perfect running conditions (Complete in all respect as per inventory) to the department.
- 11 Water and power shall be made available free of cost for bonafide users.
- 12 Initially maintenance contract shall remain valid for one year and it may be renewed /extended every year for further two years thus making total three years on the same terms and conditions subject to satisfactorily performance during the contract period. Nevertheless, the first party may terminate the contract of the second party without any notice in case the contractor commits breach. 13. During the contract period, if the performance is not satisfactory performance guarantee can be forfeited.
- 14 Any damage resulting to the system on account of negligence or mall operation shall be made good by the contractor. Nothing extra will be paid for such work.
- 15 The contractor shall arrange to render efficient service as outlined in this specification. However in case he fails to maintain the service to the satisfaction of the Engineer in charge and if NIFT has to incur any expenditure for maintaining /repairing by alternative arrangement the expenditure thus incurred will be recovered from the contractor.
