3.	Announcement of list of eligible and ineligible students after scrutiny. (Ineligible students to be notified through CMS with justification of non selection.	11 <sup>th</sup> October 2021
4.	Last date of appeals to Campus SDAC and submission of completed forms from student who were not found eligible in the initial scrutiny (Appeals to be given at the Campus only)	26 <sup>th</sup> October 2021
5.	Last date for notifying final list of eligible students at the Campus on the CMS	1 <sup>st</sup> November 2021
6.	Interviews by the Screening Committee	To be completed on or before 25 <sup>th</sup> November 2021.
7.	Approval by the Campus Director	On or before 29 <sup>th</sup> November 2021.
8.	<b>Last Date of Notifying the final Names of Students to be Awarded scholarship for the academic year by the Campus on CMS.</b>	<b>6<sup>th</sup> December 2021.</b>

*\*It may be noted that the dates for the activities listed between serial no. 2 & 7 may vary for each campus with due intimation to the students through CMS and through the SDAC and CCs. However, the dates for Opening of Online Application (S.No.1) and Notifying the Names of the Final Recipients of SARTHAK for the academic Year 2021-22 (S.No. 8) cannot be altered.*
