Sub: Timings for availing the mess facility: for Strict Compliance.


On opening of the Institute in physical mode w.e.f. 28.02.2022 and with the arriving of students in Hostels, following timing for availing Mess facilities have been fixed.

All the students are hereby directed to strictly adhere to the scheduled Mess timings.

- **Breakfast** : 7:30 AM to 8:45 AM
- **Lunch** : 12:00 PM to 2:30 PM
- **Evening Snacks** : 4:00 PM to 6:00 PM
- **Dinner (Hostellers)** : 7:30 PM to 9:15 PM
- **Dinner (Day scholars)** : 7:30 PM to 8:00 PM
- **Coffee Shop Timing** : 10:00 AM to 9:00 PM

2. Non-Resident students/Day scholars can avail the mess facility upto 8:00 PM and leave the Campus premises latest by **8:00 PM**. Day scholars are supposed to avail the Mess facility on depositing the quarterly payments directly to the Canteen Contractor. There should be absolute transparency in availing the Mess facilities on payment basis, directly to the Contractor.
3. Day scholars are prohibited from entering Hostels and residential areas on pretext of any academic or sports activity.
4. In case any complaint for nonpayment or non-adherence to time slot, the facility will be withdrawn for Day scholars without any further notice. Violation of the timings will invite disciplinary action against the students.
5. The Mess shall be open as per the above schedule only. Canteen services shall be catered from the Outlet/Coffee shop near Basketball ground. The Coffee Shop will be open from 10:00 AM to 9:00 PM.
6. All the faculty and staff members are also requested to ensure that the above timings for mess and stay of Day scholar students in the Campus are stickily complied with.
