Clinical Psychologist (01) Preferably Female	Counsellor is expected to be available in the Institute on 2 to 3 days in a week for one hour. She is expected to counsel students having problem ranging from anxiety and depression arising from difficult study issues/ results / home sickness / life issues to more serious mental health problems. Life issues could include bereavement, relationship difficulties or any such issues of adolescence, while mental health problems could include eating disorders, post-traumatic stress disorder (PSTD) or psychosis.

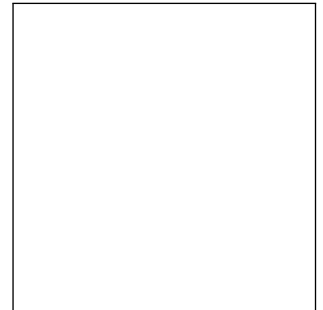
## **B. General Terms:**
