Any complaint received on this line will be immediately attended & forwarded to SDAC (sdac.shillong@nift.ac.in) for taking further action which may include collection of evidences and recording statements of all involved and submit a report with proper documentation to the 24x7 anti ragging committee for further action. A Complaint box has been placed in the reception area and any complaint received in the box will be sent to SDAC. Counseling of Fresher's and Seniors: Director of the institute and SDAC will address the incoming students and senior students and make them aware of the seriousness of ragging and how civil and sensible it is to wipe out such acts from an Institute like NIFT. Also special awareness programme will be conducted by experts invited from outside of NIFT.

Undertaking from Students and Parents: Each student of the Institute and his/her parents and/or Guardian are hereby required to submit a combined undertaking at the time of registration in the prescribed format as attached to this order, which is mandatory to registration. Also, senior students are required to submit undertaking in this regard which will be placed in original in their personal file and photocopy sent by speed post to their parents/guardians. It is imperative for all employees of the Institute (teachers, administrative staff, contract staff, caretakers, security staff, maintenance staff and cleaning staff) to report promptly any case of ragging/misbehavior that comes to his/her notice to a member of the anti-ragging committee or squads. All concerned officials of the Institute, students, parents and guardians of the students, members of Anti-Ragging Committees and Anti-Ragging Squads are hereby requested to adhere to the stipulations and effectively monitor and comply with the provisions made in directives.
