The tenderers shall submit their sealed tenders on or before 11.00 am on 21-01-2019 along with EMD of Rs.25,000/- in the form of Demand Draft/Pay Order in favour of NIFT payable at Bengaluru.

TERMS AND CONDITION:

- ✓ The sealed tenders should be super scribed with 'Tender for Disposal of old Cars' and addressed to the Director, NIFT, Bengaluru and along with the Earnest Money Deposit (EMD) of Rs.25,000/- (Rupees Twenty Five Thousand Only) should be submitted/dropped in tender box kept at Administration department at C.A. - ✓ The highest bidder or the highest tenderer as the case may be should pay 35% of tendered or bid amount (i.e., which includes EMD Rs.25,000 already deposited + Balance amount) on the same day or next day. The remaining 65% shall be paid within 10 days of acceptance of tender/bid by the competent authority, failing which the amount of EMD will be forfeited. The remaining bid amount should be deposited in the form of Demand Draft/Pay Order drawn in favour of NIFT, Bengaluru within 10 days on receipt of confirmation of sale order from NIFT.
