Sub: Observance of Vigilance Awareness Week from 30th October to 05th November 2023 - reg.

In compliance with circular no. 08/09/23 (No. 023/VGL/035), dated 11.09.2023 of Central Vigilance Commission, New Delhi, and no. 01/216/2023-Vig./401, dated 04.10.2023 of Vigilance Department, NIFT HO. Accordingly, it has been guided to observe **Vigilance Awareness Week 2022 (VAW 20223)** during the week in which the birthday of Sardar Vallabhbhai Patel (31st October) falls. The **VAW 2023** will be observed at the NIFT Bhopal, from **30th October to 05th November 2023**. The theme of this year's **VAW** is:

"भ्रष्टाचार का विरोध करें; राष्ट्र के प्रति समर्पित रहें" "Say no to corruption; commit to the Nation"

The list of proposed activities for the week are:

01. Oath: The observance of VAW 2023 shall commence with the Integrity Pledge (as per Annexure A & B of circular no. 08/09/23, 023/VGL/035, dated 11.09.2023) on 30th October 2023 at 1100 hrs. in the Courtyard area of NIFT Bhopal centre.

Action: Arrangements by RA Establishment. The task is to be completed on 30th October 2023 by all NIFT Bhopal employees. (Faculty/Officials/Staff/ Students).

- 02. **3-month Campaign:** As a predecessor to the VAW 2023, the Commission had issued instructions detailing a three-month campaign period (**16th August till 15th November 2023**) in which six different preventive vigilance measures were to be taken up by the concerned departments within the organization. Accordingly, the Accounts, Establishment, Administration, Academics, IT, and Estate departments of NIFT Bhopal were guided to follow instructions inculcating the true spirit of participative vigilance. The focal areas included the following:
 - a) Awareness building about Public Interest Disclosure and Protection of informers (PIDPI) Resolution,
 - b) Capacity Building programs,
 - c) Identification and implementation of Systemic Improvement measures,
 - d) Leveraging of IT for complaint disposal,
 - e) Updation of Circulars/Guidelines/Manuals
 - f) Disposal of complaints outstanding as of 30.06.2023

The above-enlisted activities are desired to be continued until the end of the campaign period. The works undertaken on these parameters should be submitted (as per Annexures D (i) to D(iv) circular no. 08/09/23, 023/VGL/035, dated 11.09.2023) for onward submission to CVO, NIFT-HO.

Action: The task is to be completed by 22^{nd} November 2023 by various concerned departments of NIFT Bhopal, and the information is to be submitted in the given formats as per the circular.

03. **Online Integrity Pledge:** All the employees are encouraged to participate in the e-pledge accessible at <u>https://pledge.cvc.nic.in/</u> through the CVC website, open to everyone including the families of NIFT Bhopal faculty/official/staff and affiliated organizations/vendors. Ensure submission of the pledge certificates to DVO Bhopal at <u>vigilance.bhopal@nift.ac.in</u>, with a copy sent to the Establishment Dept. NIFT Bhopal at <u>establishment.bhopal@nift.ac.in</u>.

Action: Task to be completed by 15th November 2023 by all the NIFT Bhopal Officers/Faculty /Staff/Students. RIC to inform Alumni NIFT Bhopal.

04. **Poster Design Competition:** The competition will be organized for the students of NIFT Bhopal to participate in it. DVO & SDAC NIFT Bhopal will organize the event. The entries will be judged by a Faculty Club coordinator, SDAC, and DVO. The competition details are to be worked out by the team and informed accordingly.

Action: DVO and SDAC NIFT Bhopal will work out the details and organize it.

05. Essay writing competition: Essay writing in the Hindi/English language will be conducted for students, officers, faculty, and staff of NIFT Bhopal. Dr Rajdeep Khanuja, Mr Ayan Tiwari, and Ms Samta (JTO), NIFT Bhopal, will be on the Jury. The essay competition will be conducted on 03rd November 2023 (Friday) from 4:00 to 5:30 pm.

Action: DVO and SDAC NIFT Bhopal will work out the details and organize it

06. **Social Media:** The NIFT Bhopal's social media team shall be responsible for documenting and sharing updates on all activities taking place during VAW 2023, for all of NIFT Bhopal's social media platforms.

Action: The Social Media team will work out the details and act accordingly.

07. **Press & Print Media:** Local newspapers and journalists to be informed about the events for coverage. Photographs and media clips will be uploaded on the NIFT Bhopal's website and other social media handles. The task is to be completed by **15th November 2023.**

Action: Media Liasoning Officer/IT-Incharge/Webmaster NIFT Bhopal

08. **Printing:**

Banners: 02 banners (6ft x 4 ft) will be printed in Hindi (01) and English (01), mentioning the duration and the theme of the VAW 2023 along with the NIFT Logo, 75^{th} Independence, G20 Summit logo, and other necessary logos. These will be displayed at various places within the NIFT premises. Printing is to be done before **25 October 2023**.

Certificates: 50 Certificates to be printed for all the winners and participants of all competitions of the 3-month campaign and VAW 2023 events.

Action: Purchase/Accounts Dept. NIFT Bhopal.

09. Action Taken Report: The VAW 2023 action taken report has to be sent to CVO by 22nd November 2023 (as per Annexures D(i) to D(iv) and Annexure F) of the CVC circular in MSWord. The task should be completed by 24th November 2023 at the centre level.

Action: DVO NIFT Bhopal, All concerned department Heads, Faculty, Officials, and Staff.

- 1. DVO NIFT Bhopal will send an email to all the Officers/Faculty/Staff/ Students of NIFT Bhopal to encourage them to take Offline as well as E-Pledge and submit their certificate to DVO as well as a copy to the Establishment department.
- 2. Ms Samta (JTO) will translate the Integrity oaths from the English to the Hindi language.
- 3. RIC NIFT Bhopal to inform Alumni NIFT Bhopal to take E-Pledge.
- 4. DVO and SDAC NIFT Bhopal will work out details and make necessary arrangements for the Poster Design and Essay competitions.
- 5. Social Media Team NIFT Bhopal will coordinate with students for photography and short videography of various activities for social media uploading.
- 6. Media Liasoning Team NIFT Bhopal to coordinate with local Newspapers and Journalists.
- 7. DVO will coordinate with Purchase Team NIFT Bhopal regarding the various printing requirements.
- 8. Administration support will be requested, if and when needed.
- 9. Dr Rajnish Tamrakar (RA-Establishment) will be responsible for the overall management of all events during VAW 2023.

Theme: "भ्रष्टाचार का विरोध करें; राष्ट्र के प्रति समर्पित रहें" "Say no to corruption; commit to the Nation"

Bringing transparency and accountability in governance remains one of the primary means to achieve all round development of the country. The Central Vigilance Commission, as the apex integrity organization of India, adopts different initiatives to strive towards ensuring integrity in public administration. Vigilance Awareness Week is one of the tools of the Commission in increasing public awareness about the perils of corruption. Vigilance Awareness Week is observed every year during the week in which the birthday of Sardar Vallabhbhai Patel (31st October) falls in. The Commission has decided that this year Vigilance Awareness Week would be observed from 30th October to 5th November, 2023 with the following theme:

"भ्रष्टाचार का विरोध करें; राष्ट्र के प्रति समर्पित रहें"

"Say no to corruption; commit to the Nation"

2. The observance of Vigilance Awareness Week, 2023 would commence with the taking of the integrity pledge (copy enclosed at the **Annexure A**) by public servants in the Ministries / Departments / Central Public Sector Enterprises (CPSEs) / Public Sector Banks (PSBs) and all other organizations on 30th October, 2023 at 1100 hrs.

3. In a move towards inculcating the true spirit of participative vigilance, the Commission had earlier issued instructions detailing a **three-month campaign period (16th August, 2023 till 15th November, 2023)** in which following preventive vigilance measures were to be taken up as focus areas by all the Ministries / Departments and Organizations:

- a. Awareness building about Public Interest Disclosure and Protection of Informers (PIDPI) Resolution,
- b. Capacity Building programs,

- c. Identification and implementation of Systemic Improvement measures,
- d. Leveraging of IT for complaint disposal,
- e. Updation of Circulars / Guidelines / Manuals,
- f. Disposal of complaints received before 30.06.23.

4. All organizations are advised to conduct activities relevant to the theme that strives to bring about maximum public participation. It is imperative that all organizations should conduct different outreach programs that aim to sensitize the public about the need for transparency and integrity in public governance. A poster on PIDPI has been prepared and is available at **Annexure C.** The poster may be widely circulated and translated to regional languages, wherever feasible. You may prepare your own posters too.

5. Action taken report regarding the six Preventive Vigilance measures that are to be taken up as focus areas during this three-month campaign period should be sent by all to the Central Vigilance Commission as per the format enclosed at Annexures D (i) to D(vi) by 8th December 2023 (Friday).

6. During Vigilance Awareness Week 2023, special emphasis may be given to engage the youth in various activities emphasizing the importance of integrity and ethics. Organizations should promote activities that involve the youth and foster an environment that re-affirms the importance of their involvement in the fight against corruption.

7. Activities to be conducted within the organizations may include the following:

a. Employees may be encouraged to take e-pledge by visiting the website. Online "Integrity Pledge" is available at CVC's website (<u>www.cvc.gov.in</u>) and can be accessed by all.

b. Conduct workshops/sensitization programs for employees and other stake holders on policies/procedures of the organization and on Preventive Vigilance measures.

c. Vigilance Study Circles may conduct different outreach and awareness programs.

d. Conduct various competitions such as debates, quiz etc. for the employees and their families on issues relating to anti-corruption.

e. Promote the concept of e-Integrity Pledge by persons with whom the organization deals with.

- 8. Outreach activities for public / citizens may include the following:
 - a. All Ministries / Departments / Organizations shall publicize integrity Pledge amongst all employees, their families, vendors / suppliers / contractors / stake holders, students etc. to elicit wider participation. Integrity pledge for citizens and organizations enclosed at Annexure A and B.
 - b. Organizations may undertake activities such as walkathons, marathons, street plays etc. which have visibility and mass appeal across all strata of society.
 - c. Extensive use of social media platforms, bulk SMS / e-mails, WhatsApp etc. for spreading awareness. For different social media related initiatives, the social media handles of the Central Vigilance Commission may be tagged. (Twitter: @CVCIndia; Facebook: CVCofIndia)
 - d. Organize grievance redressal camps for citizens / customers by organizations having customer-oriented activities. Similarly, vendor meets may be organized wherever necessary, through online mode or otherwise, whichever is more feasible.
 - e. Organize "Awareness Gram Sabhas" for dissemination of information regarding the menace of corruption and the different measures that the public can undertake to redress it, such as complaint portals, etc. As per past practice, Public Sector Banks need to conduct "Awareness Gram Sabhas" at the Branch level in at least two Gram Panchayats. Other organizations may also organize wherever possible. Indicative list of activities which can be conducted as part of "Awareness Gram Sabhas" is at **Annexure E**.

9. Selected Photographs / Media clips may be sent to the Commission by email at the address **coord1-cvc@nic.in.** Photographs and Media clips may be uploaded on departmental / organizational websites.
