Sealed tender are invited on behalf of the National Institute of Fashion Technology from reputed and eligible agencies who have carried out similar work with Govt. departments/PSU"s/Pvt./MNC"s, for civil works at NIFT Campus Bhopal. The terms and conditions of the contract which will govern the contract made are those contained in the General terms and conditions applicable to the contracts are detailed in the tender form and its schedules. Please submit your rates in the tenders form if you are in a position to complete the work in accordance with the requirements stated in the attached schedules at NIFT Bhopal. The tenders shall be super scribed with "**Need to level the uneven land in NIFT Bhopal campus**" The Earnest Money in the form of online/RTGS/NEFT/Pay Order should be after the date of publishing of tender date, payable in favour of "NATIONAL INSTITUTE OF FASHION TECHNOLOGY Bhopal". NIFT shall have the authority to cancel the tender process if NIFT does not find a suitable tender. NIFT shall have the right to call for fresh tender in such circumstances, wherein Tenderers who have bid in the previous tender, shall have the right to participate in the fresh process. The tenderers shall have no right to challenge the authority and decision of NIFT to cancel the tender process for the reasons deemed fit by NIFT. The site can be inspected any time during working hours on any working days. No extra money shall be payable by NIFT for non-awareness of the site conditions and constraints.

OVERVIEW OF THE WORK

Location - The work is to be executed inside NIFT Bhopal Campus located at Bhopal Indore Bypass Road, Bhauri, Bhopal-462030.

General Scope of Work:

- (a) The Successful Bidder must complete the work of level the uneven land as per CPWD/IS code specification.
- (b) The Successful Bidder shall be responsible to complete the works in all respects and satisfactory performance of the complete system.
- (c) The Successful Bidder shall be responsible to complete all the works, as per direction of Engineer in charge, associated with **Need to level the uneven land** work. All material, manpower, tools, JCB, loader, unloader, cutter, tractor, trail, Dozer, work etc shall form part of the scope of work.
- (d) Supervision, adherence to applicable labour and other laws, workmen compensation, transportation, etc shall be the responsibility of the Successful Bidder.
- (e) After completing the work, that place has to be cleaned properly.

The financial bid envelope must contain only the financial bid. The financial bid shall include all the charges including all taxes etc to complete the work in all respect. NIFT will not accept any claim other than mentioned in financial bid.

(e) The interested agencies are advised to read carefully the entire tender document before submitting their tender and the tender documents not received online in prescribed format and/or are found incomplete in any respect shall be summarily rejected.

2-General:

(a) All information called for in the original tender document should be furnished, in Hindi/English, against the relevant columns. If for any reason, information is furnished on a separate sheet, this fact should be clearly mentioned against the relevant column. Even if no information is to be provided in a column, a "nil" entry should be made in that column. If any particulars /queries are not applicable in case of the applicant, it should be stated as “NA”. The applicants are cautioned that giving incomplete information, giving misleading or false representation, not giving information in clear terms, deliberately suppressing the information, giving false statements, not providing correct enclosures or making any change in the prescribed forms, shall result in the application being summarily rejected.

(b) The application should be in printed form. The bidder should fill up information in all the columns and sign each page of the application as well as the submitted documents. EOI shall be submitted in the prescribed format only along with all supporting documents as required. EOIs which are not in prescribed format or are incomplete or submitted without requisite documents shall be summarily rejected.

(c) Information should be filled with neat legible and correct entries. Indistinct figures, erasures and alterations are not permitted in the tender Overwriting should be avoided. Correction, if any, should be made by neatly crossing out, rewriting and authenticated by initialing with date.

4. Evaluation of bid and selection of successful bidder shall be based on. No tenderer shall be allowed to withdraw the tender rates after opening of the tender. 5. Rates should be offered unconditionally and if rates are submitted with any condition the tender shall be rejected.

of work, site conditions and access to the site and location before submission of the tender.

TERMS AND CONDITIONS AND SCOPE OF WORK:

1. Please read the terms & conditions carefully before filling up the document. Incomplete tender documents will be rejected.

2. The Financial Bids of technically qualified bidder only will be opened Conditional or offline tender will not be accepted or the condition(s) may not be considered.
3. Even after qualifying in technical bid, the financial bid may not be accepted if found not in order.
4. In case of L-1 is more than one, the selection criteria [viz. the past performance, experience, turnover, etc.] would be at the discretion of NIFT. The decision of NIFT, in this regard and for selection of successful bidder in such situation, will be final in all respect and will be binding on all the tenderers.
5. Lowest bid may not be the only criteria for selection and NIFT is not bound to issue work order to the agency being the 'L-1' bidder; weightage/ preference will also be given to the other factors, viz. previous experience, quality of service, number of client, yearly turnover, etc. to select the agency to award the work and the decision of NIFT in this regard and for selection of successful bidder will be final in all respect and will be binding on all the tenderers.
6. The rates shall include cost of labors, transport & material, tools, machines, etc., for the works complete in all respects. The quoted rates shall include all taxes and GST as applicable and no extra amount shall be payable on this account. Rates shall be valid for six months from the date of opening of financial bid.
- 7-Works are to be carried out as per CPWD specifications.
8. The successful bidder needs to deposit Security Money of 10% of the Work Order value through online/RTGS/NEFT NIFT bhopal which will be refunded/ returned, without any interest, after one year from the date of completion of the work with deduction, if any and as applicable.
9. The works should be completed within 12 weeks from the date of receiving of Work Order failing which a penalty @0.5% of the order value per week will be imposed subject to a maximum of 10% of the Order Value. However, delay due to any applicable/ unforeseen reason, viz. natural calamity, non-availability of site etc., may/ be considered and decision of NIFT BHOPAL in this regard shall be final and binding on all.
10. All statutory obligations under various laws, imposed from time to time will have to be met by the contractor for which no extra payment shall be made to him. NIFT will no way be responsible for any default with regard to statutory obligation, if any.
11. It will be the sole responsibility of the Licensee to abide by the provisions of the following acts as to the workers engaged by him for performance of this contract.
 - (a) Minimum Wages Act 1948.
 - (b) Employee Provident Fund Act 1952

 - (g) Payment of Bonus Act and Rules 1965
 - (h) Workmen compensation Act 1923
12. The contractor shall be personally responsible for compliance of Municipal by laws relating to sanitary conditions and provide liveries to the personnel employed by the contractor. Proper care should be taken to provide adequate protection to the existing structures and cables (Telephone, electrical, computer etc.), all such installations against any damage/defect to the existing structure arising due to faulty execution

of work shall have to be rectified as directed to the satisfaction of Engineer In Charge without any extra charges.

13. The quantity of items of work may vary and payment will be made based on actual.

14. All expenses related to the functioning of the employees engaged by the contractor shall be in the scope of the contractor.

15. NIFT shall not provide any mode of transport in respect of men or material required by the contractor for execution of the work.

16. The schedule issued with the form of tender listing the details of item to be executed must not be altered by the tenderer. Any modifications/ alterations of the schedule considered necessary by the tenderer should be in a separate letter accompanying the tender.

17. The quotes should be valid for at least 3 months from the date of opening of the tender however, for the successful bidder the rates will be valid till completion of the job Statutory rates are subject to change and will be considered as may fixed by the Govt.

18. The tender is liable to be rejected if complete information is not given or if the particulars and data (if any) asked for in the Schedule of the tender are not filled in correctly.

19. Tender shall be accompanied by the relevant documents including the following: -

A. Self-attested copy of Trade License

B. Self-attested copy of GST Registration

C. Self-attested copy of PAN of the company/firm

D. Self-attested copy of Professional Tax

E. Annual Turnover F. Experience

20. The items used in the work shall be of good quality and of a reputed brand

21. Cleaning of the area where work is being executed or any other area affected due to the work being carried out by the contractor shall be the sole responsibility of the contractor. The contractor is responsible for removal and disposal of waste/garbage from such areas on a daily basis.

22. The licensee should ensure that all the employees are free from communicable diseases. Medical Certificate to this effect should be available for inspection by the authorities. If any worker is found to be medically unfit, he/she may not be given permission to continue his/her duties and licensee has to replace them immediately without fail.

23. Liability/responsibility in case of any accident, causing injury/death to shop worker or any of his staff shall be of the contractor. The Institute authorities shall not be responsible in any means in such cases.

24. The licensee shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency.

25. Designated authority of the Institute will supervise the work.

26. The Licensee shall be wholly responsible for payment of any and all taxes including but not limited to commercial property tax, sales tax, GST, duties cess under the existing or future Laws, acts, Rules,

Orders, Notifications etc, issued by the Central or State Governments or any local authority, or body in respect or in connection with supplies and NIFT shall not be liable to pay such taxes, rates, duties etc., whether existing or which may accrue in future.

27. The licensee shall ensure that all persons employed by the licensee are well mannered and display courteous behavior.

28. No accommodation, no changing/resting room, will be provided to the workmen of the licensee.

29. Failure to start work in time after issuing of work order or involvement of the licensee in illegal, unethical, violent activities or breach of any terms and conditions of the agreement will lead to debarment of the licensee from participating in any of the Tender/EOI of the institute.

30. NIFT Bhopal reserves the right to terminate the contract at one month's notice without assigning any reason, for which no compensation / damages will be paid. The contractor shall remove himself / herself from the said premises with all belongings and leave it entirely vacant within one month of the date of notice of revocation or termination of the contract. In case the contractor is desirous of terminating the contract before expiry of the period agreed, then contractor shall provide three-month advance notice in writing to NIFT Bhopal. The termination of the contract shall not release either party of its obligation to pay any sums then owing to the other party and also perform or discharge any liability that had been incurred prior thereto.

31. The successful bidder will have to make an agreement with NIFT Bhopal on terms and conditions of the contract on stamp paper. The contractor shall bear and pay all the costs / charges and expenses incidental to the preparation and execution of the signed agreement in duplicate. The Institute shall retain the original contract document and the contractor shall keep the duplicate of the same.

32. Violation of any of the terms of agreement, record of poor performance such as abandoning work, not properly completing the Contract, or financial failures /weaknesses etc may lead to termination of contract.

33. In case of a legal dispute arising out of or relating to the agreement or breach, or the invalidity thereof, shall first be attempted to be settled by discussions. If the same is not resolved through mutual discussions, then the same shall be referred to the sole arbitration of the Director, NIFT Bhopal or any person nominated by him. The decision of the Arbitrator shall be final and binding on both the parties.

All disputes are subject to Bhopal (MP) jurisdiction only.

Payment Terms:

- a) Payment will be made as per actual work measurements of **level the uneven land** works and released against original invoice after verification of the work and certification of satisfactory completion of the work by the respective NIFT Authority.
- b) Statutory recoveries (TDS, GST etc.) if applicable will be deducted from the invoice amount as per Rules. 10
- c) No payments shall be made in advance. The payment shall be made after completion of works and on the basis of certification by the concerned NIFT Officials. TDS etc., if any and as applicable, will be deducted during payment.
