1.INTRODUCTION OF NIFT:

National Institute of Fashion Technology (NIFT) was set up by the Ministry of Textiles, Government of India in 1986 which has been accorded statutory status under the Act of Parliament in 2006 (NIFT Act 2006) for the promotion and development of education and research in the field of Fashion, Management and Technology. NIFT provides fashion business education across the country through its network of 19 centres.

It provides four years Under Graduate (UG) program in Design and Technology, two years Post Graduate (PG) program in Design, Fashion Management & Fashion Technology and a short duration education program to address the specialized needs of professionals and students in the field of Fashion. NIFT has its head office at New Delhi with its campuses located at Bengaluru, Bhopal, Bhubaneswar, Chennai, Daman, Gandhinagar, Hyderabad, Jodhpur, Kangra, Kannur, Kolkata, Mumbai, New Delhi, Patna, Panchkula, Raebareli, Shillong. Srinagar and Varanasi. NIFT, Chennai was established in the year 1995 and situated at NIFT, Campus, Rajiv Gandhi Salai, Taramani, Chennai — 600 113.

2. SCOPE OF WORK:

NIFT Chennai invites sealed Tenders under for Supply of Dress Forms as per the quantity and specification mentioned in the price bid. This procurement is being undertaken under PAC basis in favour of M/s. Figurettes Inc., New Delhi, being the sole manufacturer of the required Dress Forms of the specified quality." The tender bids duly-filled in all respects enclosing necessary documents may be addressed to The Director, National Institute of Fashion Technology, Rajiv Gandhi Salai, Taramani, Chennai – 600113 so as to reach on or before **01.00 PM**, **19.09.2025** or the tender may be dropped in Tender Box placed at 'Room No: 41, NIFT Campus Main Building, Rajiv Gandhi Salai Taramani Chennai-600113 on or before **19.09.2025 -01.00 PM**.

3. ELIGIBILITY CRITERIA

The Tenderer must fulfill the following eligibility conditions:

- I. Dress Forms Manufacturers (OEM) or their Authorized Agents is only eligible to apply.
- II. The Tenderer should have an annual turnover of at least Rs.1 Crore during the last three financial years. Turnover certificate shall be issued by a Chartered Accountant based on audited financial statements.
- III. Tenderer should be a supplier of similar Dress Forms for at least five years. The tenderer should submit copies of supporting records to prove this condition.
- IV. The tenderer should have supplied dress forms at least 01 order to any one of NIFT Campuses in the last 03 years.
- V. The Tenderer should provide warranty/guarantee and Free Service for a period of minimum one year from the date of installation.
- VI. The tenderer should not have been blacklisted by any State Government/Central Government and/or any Central PSU.

4. MODE OF SUBMISSION:

- 1. Tenders documents with sealed cover should be addressed to the Director, NIFT Campus, Rajiv Gandhi Salai, Taramani, Chennai 600 113, Tamil Nadu.
- 2. Tender cover should be super-scribed as Tender document for "Supply of Dress forms" The tenders will be opened on the same day at 4.00 p.m. in the presence of such of the Tenderers who may wish to be present, either by themselves or through their authorized representatives.
- 3. NIFT Chennai will not be responsible for any delay or loss of document in transit due to any reason.
- 4. Tender document will be issued from 9.00 am to 5.00 pm on all working days as mentioned in the Tender schedule. The sealed tenders should be reached to the Director, NIFT, Rajiv Gandhi Salai, Taramani, Chennai 600 113 on or before the date as mentioned in the tender notice. The tenders received after due date and time or unsealed or incomplete or by electronic mail will be summarily rejected.
- 5. Filled in Tenders shall be submitted in official tender form only issued by the Institute or downloaded from the NIFT, Chennai website. If submitted in any other form, it will be summarily rejected.
- 6. The name and address of the Tenderer shall be clearly filled in the space provided and no overwriting corrections, insertion shall be accepted in any part of the tender unless duly countersigned by the Tenderer. The tender shall be filled in and submitted in strict accordance with the instructions laid down herein otherwise the tender is liable to be rejected.

5. GENERAL TENDER TERMS & CONDITIONS:

- 1. Please read the Terms & Conditions carefully before filling up the document.
- 2. Incomplete tender documents will be summarily rejected.
- 3. Tenderer is required to submit **Earnest Money Deposit (EMD)** of **Rs.1,25,000/** (One lakh twenty-five thousand only) in the form of Demand Draft (should be drawn after the date of notification of this NIT) in favour of NIFT Chennai payable at Chennai. No interest shall be paid on the EMD and will be returned after finalization of the tender; however, the EMD of the successful Tenderer will remain with NIFT and will be forfeited in the following events:
 - a. (a). If information declared/document submitted found false/fake/forged
 - b. (b). If the successful Tenderer does not accept the W.O., or, unable to provide services.
 - c. (c). If the Tenderer withdraws his bid/quote
- 4. No overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender should be filled in and submitted in strict accordance with the instructions laid down herein; otherwise, the tender is liable to be rejected.
- 5. The quote/rates should be valid at least 3 months from the date of opening of the tender; however, in case of the successful tenderer the quote/rate shall be valid for the entire period of contract and during extended period. Prevailing statutory rates (S. Tax, GST etc.) as revised by the Govt. from time to time will be considered.
- 6. The tenderer should not be black listed by any department of the Central or State Government or PSU or any other organization. The service provider must give an undertaking in this regard.

- 8. All disputes, if any are subject to Chennai Jurisdiction only.

6. RELEASE OF PURCHASE ORDER:

- 1. It is not binding on the part of the Director, NIFT Chennai to accept the lowest bid or any other tender and Director reserves the right to reject / accept any tender fully or partly or retender without assigning any reason.
- 2. The Director, NIFT Chennai is also reserves the right to relax or waive any of the tender conditions and reject the tender if any one of the conditions enumerated above, is violated or any condition given by the tenderer.
- 3. The quantity may increase or decrease depending on the requirement.

7. LIQUIDATED DAMAGES (LD)

- 1. In case the supplier fails to deliver the goods or complete the installation within the stipulated time, liquidated damages at the rate of 0.5% of the total order value per week of delay or part thereof, subject to a maximum of 10% of the total order value, shall be levied by NIFT Chennai. Beyond this period, NIFT Chennai reserves the right to cancel the order and forfeit the Performance Security, if any, without any further notice.
- 2. In order to take care of the situation arising out of the failure of the tenderer to supply as per the schedule and quality and norms, the orders placed with such tenderer will be cancelled.
- 3. Delivery of goods shall be made by the tenderer at NIFT Chennai in accordance with the terms specified by NIFT.

8. WARRANTY

The supplier shall provide a comprehensive onsite warranty at least for a period of **1 year** from the date of installation. During the warranty period, all defects shall be rectified free of cost.

9. PERFORMANCE SECURITY DEPOSIT

On successful delivery and commissioning of the Dress Forms, and upon certification by the Indenting Departments, 95% of the invoiced amount shall be released. The remaining 5% will be retained as Performance Security, valid for 60 days beyond the warranty period of one year (i.e., 14 months in total).

The retained amount will be released after satisfactory completion of the warranty period and submission of a performance report by the user department. No interest shall be payable on the Performance Security.

10. PAYMENT TERMS:

The payment shall be made on production of satisfactory supply / installation certificate issued by NIFT user department. The payment will be made within three to four weeks after satisfactory supply/installations of the items.

11. JURISDICTION FOR LEGAL PROCEEDING:

Suit or any legal proceedings in regard to this matter arising in any respect under this contract shall be instituted in any court in Chennai only.

12. SAVING CLAUSE

- 1. In case any doubt arises on interpretation or otherwise of any point in this tender document, NIFT shall be referred to for clarification.
- 2. At any time after the issue of the tender documents and before the opening of the tender, the Tender Inviting Authority may make any changes, modifications or amendments to the tender documents and shall send intimation of such changes to all those who have purchased the original tender documents.
- 3. In case any tenderer asks for a clarification on the tender documents before 48 hours of the opening of the Tender, the Tender Inviting Authority shall ensure that a reply is sent and copies of the reply to the clarification sought will be communicated to all those who have purchased the tender documents without identifying the source of the query.
