B. CLARIFICATION REGARDING DOMICILE SEAT

As given in the Prospectus 2020 and notification dated 24th July, 2020

How is domicile category determined?

The candidate would be determined to be the domicile of that State within which the candidate has completed his/her class 12th examination (for Under Graduate course) and graduation/qualifying degree (for Post Graduate Course). A certificate from the concerned school/college is to be obtained. In case the candidate obtained the qualifying certificate/degree through Distance Learning mode, the address of the school attended by the candidate regularly will determine his/her domicile status. Seat availability under the State Domicile Category Seats will be offered for admission as State Domicile Preferential Seats to candidates who belong to the 9 States where the following NIFT campuses are located:
