- 6. Ensure the signatures of the student & parents wherever applicable
- 7. Applications & all supporting documents should be uploaded in the CMS portal only. No hardcopy submission or Emailing will be entertained.
- 8. Students are informed to complete the process well before 28.02.2024 and do not wait till the last date to avoid any technical issues. Do not send any mail at the last moment informing login issue and etc
