ADMISSION ONLINE COUNSELLING 2020

CLARIFICATION ON PENDING PAYMENT VERIFICATION

It has been noticed that despite Instructions in multiple Notifications issued earlier for paying the Fee through **NIFT Portal only**, some candidates have remitted/ are remitting the Fee by NEFT from Various Accounts and through Company / Organization.

Such payments are very difficult to get identified as NIFT gets only the Transaction ID and do not get the Name of Candidate, CMR and the Course and nearly impossible to correlate the payment received against the Name of the candidates and their payments are not getting Verified.

We have found various Scenarios for such candidates who may kindly take necessary action at the earliest, so that their candidature can be verified for Counselling.

Some applicants are facing the problem that payment successfully made through Payu Payment gateway mode is not updated in the Admission portal due to technical difficulty / internet connectivity or other issue and it is continuously indicating “payment not yet made “	Such applicant is requested to please do not remit the fee again. Payment already made will get offline captured in the admission portal by NIFT technical team before the start of online counseling of both PG & UG courses								
3.
