परिचय:

NOTICE INVITING TENDERS

1. Introduction

The National Institute of Fashion Technology (NIFT Campus Hauz Khas, New Delhi) invites online tender from the experienced contractors for **“SITC of 50 nos. of New Split Air Conditioner at NIFT Delhi Centre, Hauz Khas, New Delhi”**.

2. Earnest Money Deposit (EMD):

बयाना राशि (EMD) राशि: Rs. 100000/- (in form of Demand Draft), Validity : 90 Days

3. Site Visit:

The bidder is advised to acquaint himself with the job work, visit the Site & examine site conditions, climatic conditions, labour, power, material availability, transport and communication facilities, environmental regulations, laws and bye- laws of statutory, local bodies and the Govt. of India and collect all information that shall be necessary for preparing the bid and entering into a contract.

The cost of visiting the site and collecting information for the purpose of submission of the bid shall be incurred by the bidder only.

The bidder and any of his personnel or agents will be granted permission by the Employer to enter upon the site for the purpose of such inspection.

4. Defect Liability Period:

The work/ materials of the contractor shall be under 12 months Defect Liability Period (DLP). Any defect/-s noticed during the defect liability period shall be rectified by the contractor without any cost to NIFT Campus, Hauz Khas, New Delhi, failing which the Security Deposit of the Contractor will be forfeited and he will be debarred from any future tendering process in the institute. If the contractor withdraw or modify their bids / tender during period of validity etc., EMD shall; be forfeited and he will be disqualify from bidding / tender in any contact with the NIFT & its campuses for a period upto two (02) years.

5. Detail of required Experience Certificates /Work orders:

5.1 The Applicant to meet the following minimum experience during last 7 years:

A (1) one similar completed work costing not less than 80% of total tender estimated cost.

Or

A(2) Two similar completed works costing not less than 50% of total tender estimated cost for each work.

Or

A(3) Three similar competed works costing not less than 40% of tender estimated cost for each work.

B. Definition of “Similar Work” Experience in carrying out similar works i.e. SITC of AC works in private sector or Govt. organizations/ PSU’s.

6. Availability of Tender document & Submission of Bids:

7. TERMS & CONDITIONS:

1. No paper shall be detached from the tender.
2. If any date mentioned above happens to be a holiday, then the next working day will be the relevant date.
3. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender shall be filled in and submitted in strict accordance with the instructions laid down herein; otherwise the tender shall be liable to be rejected by the NIFT unilaterally without assigning any reason or giving explanation to this effect.
4. The tender shall be liable to be ignored/rejected if complete information is not given there-in, or if the particulars and data (if any) asked for in the Schedule to the tender are not filled in or any wrong/false or incorrect information is given or any material thing is concealed or manipulated therein.
5. NIFT shall be entitled to initiate appropriate legal proceedings against the tenderer for the losses suffered by it as a result of the same.
6. The all rates/total amount shall include GST (as applicable), cost of labors & material for the works complete in all respects and no extra amount shall be payable on this account.
7. Water and Electricity shall be provided free of cost at one point for bonafide use only.
8. The payment shall be made in following phases:
 1. At the time of delivery: 60% of the contract value
 2. After commissioning and submission of bill: balance 40% (Final payment)The final payment shall be released after submission of bills (as per actual measurements of works) , other documents, as mentioned in the NIT and after successful completion of work by the contractor.

9. Technically qualified bidder will be informed present at the time of opening of financial bid.
10. The payment shall be made on the submission of bill, as per actual measurements of works and after successful completion of work by the contractor.
11. Tender of any agency not adhering to the above mentioned terms of the tender shall be rejected out rightly.
12. Technically qualified bidder will be informed present at the time of opening of financial bid.
13. The difference of rates in words and amount found in tender, the final amount will be considered after only final calculations i.e. (Quantity X Rates) and grand total of all items with GST.
14. Agency is required to supply minimum quantity of the material (as per cpwd analysis of rates) before starting the work.
15. Agency is required to verify the works from Engineer-in-charge on each stage. Failing which the Suitable action will be taken. For the Safety, agency is required to arrange barricading, scaffolding and net etc as required and no additional payment shall be made for their safety arrangements.
16. The support document for the genuine products needs to be submitted. The Material should be ISI Marked and tested as per list IS Code. The copy of challan/ bills of the product fixed / utilized copy will be submitted in the office.

8. Selection Criteria: The work will be awarded to L1 vendor on overall basis. The determination of lowest bidder will NOT be on individual rates of financial bids. Rather it will be on overall basis of Grand Total of all items with GST.

The following documents / information shall be attached along with Technical Bid as follows:-

- A. Copy of Pan Card.
- B. Copy of last latest three year ITR
- C. Experience Certificates/ Works Orders as mentioned in Clause no.5.
- D. All NIT document shall be signed by contractor or partner or proprietor with rubber stump of contractor/ agency and mobile no. attached with technical bid of e-tender.
- E. Financial bid should be filled online only
- F. GST registration certificate of the contractor/ agency / firm.
- G. Minimum Turnover of the agency should be at least Rs. 10.51 Lakhs each year during last 3 years.
- H. The tender of any agency without above shall be rejected out rightly.

9. Time of Completion

The work shall be duly completed within 45 days from the date of receiving of work order by the agency. **The quoted rates shall be valid for 06 months from date of receiving of work order by the agency.**

10. Liquidated Damages/ Penalty for Delay:

If the contractor fails to complete the work within the stipulated time or time extended by the Institute (if any) liquidated damages at the rate of 1% per week (07 days) of delay subject to maximum 10% of the total contract value shall be deducted and recovered from the contractor.

19. Specifications:

The materials supplied and proposed to be used in the work shall be of requisite specifications and brand as specified in NIT. If there is no specified make given in BOQ, these will be executed as per CPWD specification.

20. Bill of Quantity:

The approx. quantities have been given in the Bill of Quantities (BOQ). Work shall be carried out as per the requirement. The quantities may vary on higher or lower side.

21. Tools & Tackles:

All tools, tackles such as other equipment as per requirement of work will be arranged by the contractor and their charges will be deemed to be included in the quoted rates, no extra payment shall be made for the same to the Contractor.

22. Risks:

Contractor shall be solely responsible for safety of his workers, working at site by following all safety norms in the trade.

All risks of loss or damage to physical property and of injury and death which arise during and in consequence of the performance of the Contract other than the excepted risks are the responsibility of the Contractor. Excepted Risks are:

- a. (i) War, hostilities (whether war be declared or not), invasion, act of foreign enemies.
(ii) Rebellion, revolution, insurrection, or military or usurped power, or civil war,
(iii) ionizing radiations, or contamination by radio-activity from any nuclear fuel, or from any nuclear waste from the combustion of nuclear fuel, radio-active toxic explosive, or other hazardous properties of any explosive nuclear assembly or nuclear component therefore.
(iv) Pressure waves caused by aircraft or other aerial devices traveling at sonic or supersonic speed.
- b. Loss or damage due to the use or occupation by the Employer of any section or part of the Permanent Works, except as may be provided for in the Contract.
- c. loss or damage to the extent that it is due to the design of the Works, other than any part of the design provided by the Contractor or for which the Contractor is responsible.

15. Performance Guarantee/ Security Deposit in the shape of DD/FDR/BG/Banker Cheque/On line payment/Pay Order

1. Within 10 days of receipt of work order from NIFT, the successful firm shall furnish the Performance Guarantee/ SD Equivalent to 08% of the contract value in the form of Bank Guarantee (from any Nationalized Bank) valid for 90 days beyond expiry of the Defect Liability Period in the format as per **Annexure – A** or in the form of Demand Draft/FDR/BG/Banker Cheque/On line Payment/Pay Order in favour of NIFT New Delhi. No interest shall accrue on this.
2. Failure of contractor to comply with the requirement of contract shall constitute sufficient grounds for cancellation of the award and forfeiture of the Security Deposit in which event NIFT New Delhi may get the work done from any other agency.

16. Contract Agreement:

NIFT will notify the successful bidder that his tender has been accepted and it will send a work order to the bidder describing the works to be carried out and the same shall be returned duly acknowledged affirmatively by the bidder as a token of acceptance and a contract agreement will be signed between both parties on the agreement form **Annexure- B**. The contractor shall present the agreement on appropriate value of stamp paper for signature of NIFT New Delhi.

17. CONCILIATION/ARBITRATION:

- a. If any dispute (s) or difference (s) of any kind whatsoever arise between the parties, the parties hereto shall negotiate with a view to its amicable resolution and settlement through a committee appointed by Competent Authority, NIFT – Delhi Campus. Which will also include members of the opposite party?
 - b. In the event no amicable resolution or settlement is reached between the parties within 30 days after receipt of notice by one party, then the disputes or differences are detailed above shall be referred to and settled by the sole Arbitrator to be appointed by Competent Authority, NIFT – Delhi Campus. With the mutual consent of the other party.
 - c. The arbitration proceeding shall be in accordance with the prevailing Arbitration and Conciliation Act, 1996 (as amended from time to time and in force when the reference is made.) and Laws of India as amended or enacted from time to time.
 - d. The venue of the arbitration shall be New Delhi, India & the language of arbitration shall be English. The fee & other charges of Arbitrator shall be determined by the arbitrator in terms of the Act and shall be shared equally between the parties.
 - e. The arbitrator shall have powers to award only such remedy as is contemplated by this Agreement, including as appropriate, injunctive relief.
 - f. The arbitrator will give the speaking and the reasoned Award. The parties will not be entitled to any pendent-lite interest during arbitration proceedings.
 - g. In case any dispute still remains unsettled, in that event, the same shall be adjudicated by the Courts of Law at New Delhi.
18. Tender shall be accompanied by all the relevant documents covered in the tender.
 23. The final payment shall be made by the NIFT only after successfully completion of work and certification from user department.
 24. The successful tenderer shall deposit 08% (including Amount of Earnest money) of the quoted price of the work as Performance Guarantee /Security Deposit with NIFT in shape of Demand Draft/ FDR / BG/Banker Cheque/On line Payment/Pay Order (in favour of NIFT, New Delhi), upto the warranty/guarantee period. No interest shall accrue on this deposit.
 25. The contractor/supplier shall ensure that he himself or his authorized representative is available for proper handing over the works/consignments at NIFT Campus, New Delhi.
 26. The NIFT is registered with the DSIR for the purpose of availing customs duty exemption in terms of Govt. Notification No. 51/96-Customs and Central Excise duty exemption in terms of Govt. Notification no. 10/97-Central Excise as amended from time to time. The duty charges are to be paid by the tenderer accordingly in case of imported items.

The Bank shall not be released of its obligations under this guarantee by any exercise by NIFT of its liberty with reference to the matter aforesaid or any of them or by reason of any other acts of
