Background - The National Institute of Fashion Technology is a leader in fashion education with the ability to integrate knowledge, traditional arts, contemporary thought, academic freedom, innovations in design and technology and creative thinking to continuously upgrade its curriculum to address the changing needs of the industry. Its history of more than three decades at the pinnacle of fashion education stands as a testimony to its focus on core values where academic excellence has been nurtured. The institute has stood as a beacon of industry-academia engagement and akey enabler in developing competent professionals.

NIFT has adopted a format of Majors, Deepening Specializations, Interdisciplinary Minors and General Electives. Interdisciplinary Minors provide individuated pathways that permit students to acquire interdisciplinary skill sets that complement major area of study or enable students to explore an unrelated area of intellectual interest.

General Electives aid in enhancing overall development of the personality, knowledge and understanding of the student in specific areas. A General Elective is a set of courses that allow co-curricular growthof the students and complement the courses being undertaken within different specializations. The General Electives have been categorized as Mandatory and Optional Courses, to ensure that essential skill sets for graduating students are acquired during the course of the programme. Through the General Elective, the student will be exposed to a hands-on, applied format of inquiry, which would help the student appreciate the core principles of the particular branch of study and correlate that understanding with the student's environment and work.

All the General Electives are credited courses, with what is desired is a selective sampling that helps give the student an understanding of the basic principles and framework at play, as well as piquing of the student's curiosity and appreciation of the aesthetic and philosophical underpinnings of the specific course. It is also desired that these are done by involving learning tools, materials and institutions (like museums, art galleries, archives, natural parks etc) that are locally accessible. The intent is to challenge the student's perspective and understanding and expand the frontiers of his/her mind, and not just cram it with information.

Objective-In pursuance of the existing guidelines of NIFT's academic curriculum, the services of an Resource Organizations (Institutions/Consultant /Agencies) need be outsourced as per the provisions contained in NIFT Academic Manual by inviting Expression of Interest (EOI) from reputed & qualified

Resource Organizations(RO) for short-listing as a pre-requisite for shortlisting ROs that can teach various GEs listed in this document. The collaborations or partnerships with these Resource Organizations/Institutes will be governed by the rules and regulations set under the MoU specific for the purpose.

Resource Organization: Private and Public entities including Consulting firms, Management firms, Universities, Colleges, Institutes of higher learning, Research institutions, Government bodies/agencies, Private agencies, Non-Governmental Organizations (NGOs) who have professional expertise in any of the courses identified as General Electives. The Resource Organization should be expert or experienced in the field, or have undertaken pioneering work.

Purpose of EOI: The purpose of this EOI is to provide interested Resource Organizations (Institutions/Consulting Companies /Agencies) to prepare and submit their responses for teaching General Elective Courses in conformity with the TOR.

Stage I- Pre Qualification Criteria

- Number Trainers/ Consultants in/associated with the Resource Organisation (Atleast 10 trainers/Consultants associated with the Resource Organization)
- Minimum experience of trainers/consultants to be at least 5 years
- Profiles of Trainers/ Consultants (educational qualifications, number or years of experience, kind of
 organizations that they have undertaken training programmes in/worked in, research papers and
 publications, other professional associations, professional achievements)

- Ability of the Resource Organization to handle multiple batches of the same course simultaneously

Payment-

- Payment will be made at the rate of INR 75,000/- per course plus GST as applicable. An additional sum of INR 10,000/- will be paid as one time module development. For repeat batches, the amount would be INR 75,000 only.
- Local conveyance will be permissible as per GOI prescribed norms

 Payment will be released within 60 days of submission of bills after successful completion of courses/courses

Course Delivery

- EOI is sought for courses to be held in Academic sessions July-December 2024 and January-June 2025 and may be extended for next semesters on the basis of feedback.
- Courses will be delivered in either linear or modular fashion as per the academic requirement
- Each course has an input of 28 hours, (including evaluation) and 2 credits.
- Specific MoU will be signed with Resource Organization once confirmed.
