6. Eligibility Conditions.

- 6.1 Manufacturers, dealers/suppliers of Computer & IT Software are eligible to apply.
- 6.2 Attested scanned copies of GST Registration certificate, PAN no. (upload copies all the documents)
- 6.3 The details of turnover of tenderer for the F.Y. 2015-16, 2016-17 & 2017-18. The turnover of any one year among three years should be of Rs.10 Lakh for providing IT solutions. The tenderer should submit copies of supporting records to prove the condition

- **9.** The Tenderers are advised to go through all the terms and conditions carefully. Reporting of any corrections or alteration, etc., after submitting the tender, will not be entertained.
- 10. The Director, NIFT Gandhinagar reserves the right to accept the whole tender or any part thereof or reject all the tenders, in the interest of the NIFT so require, without assigning any reasons whatsoever and to waive any minor discrepancy in the tenders received.

If the successful Tenderer fails to execute order / or deposit the required Security Deposit within the time specified or withdraws the tender after intimation of the acceptance of the tender or fails to comply with the conditions above or owing to any other reason, the Earnest Money Deposit / Security Deposit by tenderer, will be

12. TENDER EVALUATION CRITERIA

Tenderers who satisfy the conditions stipulated in the tender document and who have supplied all the documents required will alone be considered as qualified Tenderers. The tenders of such qualified Tenderers alone will be considered.

Item wise L1 will be considered for award of purchase order.

13. RELEASE OF PURCHASE ORDER

It is not binding on the part of the Director, NIFT Gandhinagar to accept the lowest or any other tender and he reserves the right to reject or accept any tender fully or partly or retender without assigning any reason. The Director, NIFT Gandhinagar reserves the right to accept and place the supply orders to the successful tender / tenderer.

The Director, NIFT Gandhinagar also reserves the right to relax or waive any of the tender condition and reject the tender if anyone of the conditions enumerated above is violated or any counter condition is given by the tender.

Tenderer will be required to submit Security Deposit of 10% of order value in form of Demand Draft in favor of NIFT Gandhinagar. EMD of successful bidder will be converted to Security Deposit and balance amount will be remitted by the bidder within 10 days from the receipt of Purchase order. No Interest shall be paid on Security Deposit by NIFT.

18. PRICES:

The Bidder shall quote the rates in figures as well as words. The figures should be clearly written and there should be no overwriting.

19. PAYMENT TERMS

100 % payment will be made on satisfactory delivery, installation & commissioning and after satisfactory certification from NIFT authorities.

20. SECURITY DEPOSIT

The successful tenderer (L1) has to deposit a Demand Draft of 10% of the total value of Work Order as Security Deposit (Refundable) which will be refunded after completion of one year from satisfactory installation/ commission at the Campus and certified by NIFT Authority.

21. GENERAL

NIFT reserves the right for any reduction / increase in the scope of work and the same shall be awarded to the vendor at the same unit rate mentioned in their bid.

22. VARIATION IN QUANTITES

The Director, NIFT, Gandhinagar reserves the right to accept the tender either in full or in part and either to increase or to decrease the quantities to the extent of twenty five percent (25%) indicated in the tender schedule, unless qualified by the specific limitation of the tender.

23. DISPUTE RESOLUTION

Any dispute arising with regards to any aspect of this contract shall be resolved by mutual discussions and consultations between the parties to the contract. In case the dispute remains unresolved through consultation, it shall be referred to an Arbitrator, to be appointed in consultation by the two parties involved in the dispute, as per provisions governing Arbitration Act of the country.

24. JURISDICTION

Notwithstanding any other court or courts having jurisdiction to decide the question(s) forming the subject matter of the reference if the same had been the subject matter of suit, any and all actions and proceedings arising out of or relating to the contact (including any arbitration in terms thereof) shall lie only in in the court of competent civil jurisdiction in this behalf at Gandhinagar and only the said courts shall have jurisdiction to entertain and try such action(s) and/or proceedings to the exclusion of all the other courts.
