9. L1 agency will be decided based on the Grand total amount (including GST) quoted by bidders.
10. Payment will be made only in the name of bidder firm (not in the name of proprietor/partner/ Director).
11. In case of non-performance, in respect of stipulated time period for completion or defect liability of One Year after completion of work depending upon the case, the decision of Director, NIFT shall be final.
 - i. In case of any defect noticed during the warranty / guarantee period, the authorized person of NIFT will inform / register complain to the agency via telephone/email. Such complaints shall be required to be attended by the agency within 48 hrs. including repairing/replacement of parts, etc. without any additional charge. In case any major repairs and if the unit is required to be taken out at agency's workshop, all arrangements including loading/unloading, TO and FRO Transportation, etc. shall be made by the agency without any additional charges.
 - ii. If the agency fails to attend the complaint within 48 Hrs. a penalty of Rs. 100/- per day shall be imposed to the agency. Necessary recovery of penalty shall be made from the Security Deposit.
 - iii. The defective items shall be replaced by the agency without any additional charge during warranty/guarantee period.

12. Necessary plumbing work for inlet water and outlet water shall UPVC pipes and fittings made of Astral/Inolex/Ashirwad.
