

3. The tender should be submitted in sealed cover along with EMD of Rs.7,000/- (Rupees Seven Thousand only) in form of DD/ pay order drawn on schedule bank in favor of "NIFT, Gandhinagar" payable at Gandhinagar.
4. Tenders without EMD and which do not fulfill all or any of the conditions of tender document shall be rejected outright. Tender with incomplete details is liable to be rejected subject to decision of NIFT.
5. The rate offered must be filled in the Performa of the rate inquiry letter. Any correction should be initialed by the tenderer in the rate inquiry letter liable to be rejected.
6. Rates should be offered unconditionally and if rates are submitted with any condition the tender liable to be rejected.
7. The quoted rates will be inclusive of all taxes and other charges if any, nothing shall be paid extra.
8. L1 agency will be decided based on total amount quoted by bidders.
9. The Firm should have attached necessary document like PAN Number and GST Registration certificate (if applicable).
10. **10 % of security deposit** shall be held with NIFT, Gandhinagar for 1 year and released after satisfactory performance with no defect condition without any interest.
11. The EMD of the successful Bidder shall be released /adjusted after deposition/ adjustment of required security deposit amount.
12. The EMD of the bidder will be forfeited if the bidder misleads NIFT during the course of evaluation of the tender by providing false and misleading information or backs out after being declared as L1 Agency.
13. Payment will be made in the name of bidder only and not to the proprietor/partners.
14. The defective items shall be replaced by the agency without any additional charges.
15. The successful bidder will have to supply the above requirement within the define time frame of the issuance of the purchase order, failing which the firm will have to bear the entire cost of the alternate arrangement or the fine as decided by the NIFT.
16. Payment of the supply will be released after verification and satisfactorily completion of order.
