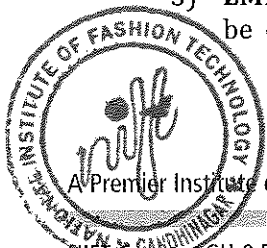

1.	Providing, making and fixing of Table of Size: (8' x 3' x 2.5'). Table top 8'x 3' and 36 to 38 mm with plywood. Front and sides to be covered with 18 mm plywood. 5mm glass has to fix on front side & there should also be drawer & space to store the speakers. All exposed surfaces shall be finished with 1mm laminate of desired shade. Vertical support (3'x 2.5' - 2nos) & (8' x 2.5' - 1nos) Pedestal Unit 16" (L) x 18" (W) x 24" (H) - (drawer: 6" - 2nos, 10" - 1nos). Foot rest should all be fixed. Drawer should be moving on telescopic channel and storage space should be with locking arrangement including all other necessary fittings. Finishing with Painting/polishing on hidden surfaces and where ever required, complete as per direction of NIFT's Engineer. The furniture should be functionally well and give good appearance. 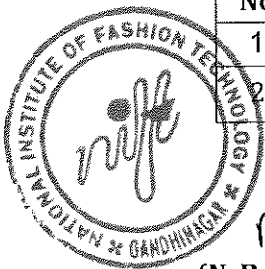
