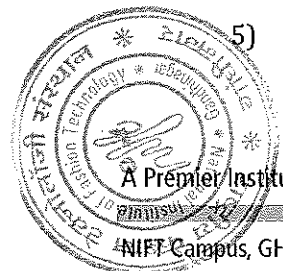

- 7) The minor changes can be held during the execution of work.

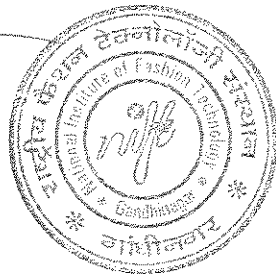
