- 16. In case of non-performance, in respect of stipulated time period for completion or defect liability of One Year after completion of work a LD will be imposed @0.50% per week subject to the maximum to 10 % of the work order.
- 17. The Agency has to complete the work within 21 days after receipt of work order.
- 18. The agency has to submit all refilled Fire Extinguisher testing certificate along with bill.
- 19. During warranty period any defect (like leakage, pressure down in pressure gauge etc.) found in refilled any type Fire Extinguisher shall be refilled by the agency without any charges.
