- 1. The tender shall be submitted in accordance with the procedure detailed herein.
- 2. Please study the document carefully.
- 3. Fill in the "Rate" column legibly.
- 4. Fill in the "Amount" column legibly.
- 5. Signed and stamped all pages of the Tender Document as a token of acceptance of the terms and conditions before uploading for online tendering.
- 6. In case the tenderer requires any clarification, he may contact Engineer of National Institute of Fashion Technology, GH 0, Extension Road, Opp. Infocity, Gandhinagar Gujarat.
- 7. The EMD is Rs. 10,000/- (Rupees Ten Thousand only) which is refundable. Same can be deposited by demand draft of national bank in favour of "National Institute of Fashion Technology" payable at Gandhinagar /Ahmedabad. No interest will be paid on Earnest Money Deposit.
- 8. 5% amount as Security deposit from billing amount shall be held with NIFT for **1** year and will be released after satisfactory performance with no defect condition without any interest.
- 9. L1 agency will be decided based on the total amount quoted by bidders.
- 10. All the material should be used of ISI or standard brand and approved brand by NIFT Engineer.
- 11. The changes can be held during the execution of work.
- 12. The quoted rates will be inclusive of cost of all material requires, transportation, labour and taxes as applicable, nothing shall be paid extra except GST.
- 13. EMD will be forfeited if the successful bidder back out after opening of quotation.
- 14. Payment will be made only the name of bidder (not in the name of proprietor/partner/Director).
- 15. In lieu of any defect the work shall be repaired by the agency if NIFT desires so.
- 16. The Qty. of items may vary at the time of execution hence payment shall be made on actual basis on submission of bill with measurement after completion of work.
- 17. Income tax / cess / taxes / other / statutory levies if any shall be deducted from every running bills and final bill payment as applicable from time to time as per Government of India / State Government rules & regulations.

OF FASHO, In case of delay of over 10 weeks in completion of the work beyond a stipulated to terminate the contract and get all the jobs completed through another agency of its choice.

- 19. Any extra expenditure that NIFT will have to incur for completion of the balance jobs through another agency on account of higher rates quoted by the agency will be recovered from the Tenderer's Security Deposit, Retention Money and pending bills.
- 20. The successful tenderer is bound to carry out any item of work up to any deviation in quantities, for the completion of the job.
- 21. The Tenderer will be responsible for theft or damaged of his material, NIFT will not compensate it by any means.
- 22. Tenderer shall be responsible for all labour law related issues.
- 23. Extra Items: All authorized extra items where rates cannot be derived from tender, the tenderer shall submit rates, supported by rate analysis worked on the 'actual cost basis' plus 15% towards establishment charges, Tenderer's overhead and profit & works contract tax etc. But decision of NIFT shall be final and binding to contractor regarding payment of that item.
- 24. Deviation in Quantities: There is no variation limit in tender quantity in plus or minus, Tenderer is supposed to execute the same at quoted rates.
- 25. In case of any dispute the Jurisdiction of Court will be Gandhinagar.
- 26. The Agency must visit the campus and Contact to NIFT's Official for clarifications about physical assessment of area/work to be executed etc. before quoting the competitive rates.
