CORRIGENDUM

Sub: Corrigendum regarding price bid BoQ for e-tender no: 8102(26)/Rect. Group-C post/2021 for "Hiring of External Agency for Recruitment of Group C posts in NIFT Gandhinagar Campus".

During the Pre-bid meeting dated 30.11.2021, it has been noticed that in "Price Bid – BoQ" the Column no: 13 & 14 (Total Amount with taxes & Total Amount without taxes) of BoQ inadvertently takes "15" as multiple as a result the final amount under above columns quoted by the bidders will be in multiple of 15.

Since amendment in BoQ at the bidding stage is not possible, it is informed to all bidders that NIFT shall considered the value quoted by the bidder in Price bid BoQ by ignoring multiple factor 15 in the public interest.
