CONDITIONS:

- 1. The quoted rates shall include all taxes, duties, GST etc. as applicable & delivery at site and no extra shall be payable on this account.
- 2. Rates shall be valid for 30 days.
- 3. The agency must enclose GST Registration certificate.
- 4. The agency should have experience in similar supplies /works. Previous Supply Order Copies may be enclosed.
- 5. Warranty to be provided for 02 years.
- 6. If the supply is not done as per the schedule, penalty equivalent to 0.5% (half percent) of the value of work will be levied per week upto a maximum of 10% of the supply order value in the event of failure of supply within the stipulated time.
- 7. The payment shall be made on the submission of bill, as per actual required specifications and after successful supply and certification by the concerned.
